ORDER GRANTING DEBTORS' APPLICATION FOR AUTHORITY TO EMPLOY NAVIGANT CAPITAL ADVISORS, LLC TO PROVIDE AN INTERIM CHIEF FINANCIAL OFFICER FOR DEBTORS *NUNC PRO TUNC* TO MAY 18, 2005

This matter came before the Court upon the application (the "Application") of the debtors and debtors in possession in the above-captioned chapter 11 cases (the "Debtors"), for entry of an order nunc pro tunc to May 18, 2005 authorizing the Debtors to employ Navigant Capital Advisors, LLC ("NCA") to provide Francis J. Conway ("Conway") to serve as the Debtors' Interim Chief Financial Officer, and to provide, subject to certain requirements,

additional NCA Personnel.² The Court, having been satisfied, based on the representations made in the Application and the Conway Affidavit, and having considered argument at a hearing held on June 7, 2005, now finds and determines that:

- 1. The Application is hereby GRANTED *nunc pro tunc* to May 18, 2005.
- 2. The limited objection to the Application filed by the United States Trustee was withdrawn in open Court based upon representations of Debtors' counsel.
- 3. The Debtors are authorized to employ and retain Navigant on the terms set forth in the revised Engagement Letter, a form of which that is substantially in the form to be executed is attached to this Order as Exhibit 1.³
