FROM MAY 1, 2003 THROUGH DECEMBER 31, 2006**

TO THE HONORABLE ROBERT E. GERBER  
UNITED STATES BANKRUPTCY JUDGE:

Cole, Raywid & Braverman, LLP (“CRB”), as special communications regulatory counsel for the above-captioned debtors and debtors-in-possession in these cases (the “Debtors”), in support of its final application (the “Final Application”) for allowance of compensation for professional services rendered and reimbursement of expenses incurred from May 1, 2003 through December 31, 2006 (the “Final Application Period”)<sup>1</sup>, respectfully requests:

## PRELIMINARY STATEMENT

1. By this Final Application and pursuant to sections 330 and 331 of title 11 of the United States Bankruptcy Code (the "Bankruptcy Code") and Rule 2016 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), CRB requests that this Court authorize (a) final allowance of compensation for professional services CRB rendered to the Debtors during the Final Application Period in the amount of \$7,180,510.71, and (b) the reimbursement of actual and necessary expenses CRB incurred in connection with the rendition of such professional services in the amount of \$311,370.42.

2. During the Final Application Period, CRB expended time, skill and effort towards, inter alia: (a) assisting the Debtors in protecting their crucial assets, including their cable television franchises, FCC licenses, state authorizations, copyright licenses, broadcast and cable programming agreements and utility pole and conduit use agreements; (b) assisting the Debtors in their compliance with statutory and regulatory obligations in the Chapter 11 environment for holders of governmental and private licenses or, alternatively, in obtaining waiver or other relief from such obligations; (c) advising on local, state and federal issues under Title VI of the Communications Act; (d) engaging in advocacy before local, state and federal agencies and other governmental units; (e) counseling on regulatory issues, including required regulatory filings as well as regulatory approvals; and (f) assisting the Debtors in obtaining necessary consents from local and state franchising authorities to transfer the Debtors' cable franchises, in connection with the sale to Comcast and Time Warner .

3. This Court has jurisdiction over this Final Application pursuant to 28 U.S.C. §§ 157 and 1334 and the "Standing Order of Referral of Cases to Bankruptcy Judges," dated July 10, 1984, of District Court Judge Robert T. Ward. Venue of these cases and this Final

Application is proper in this district pursuant to 28 U.S.C. §§ 1408 and 1409. The statutory predicates for the relief sought herein are sections 330 and 3331 of the Bankruptcy Code and Rule 2016 of the Bankruptcy Rules.

#### **GENERAL BACKGROUND**

4. On July 25, 2002 (the "Petition Date"), the Debtors filed a voluntary petition for relief under chapter 11 of title 11 of the Bankruptcy Code. The Debtors continued in possession of their respective properties and the management of their respective businesses as debtors in possession pursuant to sections 1107 and 1108 of the Bankruptcy Code.

5. By order dated July 22, 2003, CRB was retained as special communications regulatory counsel to provide services to the Debtors in connection with their chapter 11 cases. CRB's services have been substantial, necessary, and beneficial to the Debtors and to their estates, creditors, and other parties in interest. The Debtors held nearly three thousand cable television franchises and hundreds of FCC licenses and provided a broad range of video, data and voice services to over 5 million customers. Throughout the Final Application Period, the variety of issues involved cases of first impression for many of these issues in preserving these authorizations and the need to address those issues on an expedited basis required CRB, in discharge of its responsibilities, to devote substantial time by professionals from many legal disciplines.

6. CRB maintains detailed billing records based on one-tenth hourly increments of time expenses by attorneys and paraprofessionals in the rendition of professional services to the Debtors. Such time records are made contemporaneously with the rendition of services by the person rendering such services. Copies of these time records, including the number of hours expended by the partners, associates, and paraprofessionals of CRB by project category, have

previously been provided to Legal Cost Control (“LCC”) in conjunction with CRB’s submittal of invoices. Accordingly, such daily time records are not being filed herewith, but are available upon request.

7. For the convenience of the Court and parties-in-interest, annexed hereto as Exhibit B is a list of the attorneys and paraprofessionals who have worked on those matters during the Final Application Period, the aggregate time expended by each individual during the Final Application Period, his or her hourly billing rate during the Final Application Period, and the amount of CRB fees attributable to each individual.

8. CRB also maintains records of all actual and necessary out-of-pocket expenses incurred in connection with the rendition of professional services. A schedule setting forth the categories of expenses and amounts for which reimbursement is requested during the Final Application Period is annexed hereto as Exhibit C.

9. CRB specializes in communications law, including cable television regulation and franchising issues. CRB has extensive expertise in business and regulatory issues affecting the cable television and telecommunications industries. Over the past ten years, CRB has handled more cable television franchise renewals, transfers and disputes than any other firm in the country. As of January 1, 2007, the attorneys of CRB joined Davis Wright Tremaine LLP.

#### **SUMMARY OF INTERIM APPLICATIONS**

10. CRB has previously submitted to this Court Applications for Interim Allowance of Compensation for Services Rendered and Reimbursement of Expenses for the Third through Twelfth Interim Periods. A summary of the compensation requested, amounts previously paid, and amounts still pending is set forth below.

## FEE COMMITTEE CRITERIA

11. **The Final Applicant's role, objectives, and accomplishments in the Adelphia Case.** Cole, Raywid & Braverman, LLP ("CRB") serves as specialized communications counsel to the Debtors in the Adelphia case, with the objectives of: (a) assisting the Debtors in protecting their crucial assets (including cable television franchises, FCC licenses, state authorizations, copyright licenses, broadcast and cable programming agreements, and utility pole and conduit use agreements); (b) assisting the Debtors in complying, in the Chapter 11 environment, with statutory and regulatory obligations imposed on holders of governmental and private licenses, or, alternatively, in obtaining waivers or other relief from such obligations; (c) advising the Debtors regarding local, state and federal issues under Title VI of the Communications Act; (d) advocating on behalf of the Debtors before local, state and federal agencies and other governmental units; and (e) counseling the Debtors on regulatory issues, including required regulatory filings and needed regulatory approvals, including securing transfer authority for various franchises in connection with the sale to Comcast and Time Warner.

During its representation CRB has:

- Assisted the Debtors in the negotiation, renewal, and extension of certain cable television franchises, FCC licenses and authorizations, and state certifications;
- Assisted the Debtors in analyzing cable television franchise obligations and addressing related compliance issues, including franchise fee audits;
- Assisted the Debtors in receiving necessary consents from local and state franchising authorities to transfer the Debtors' cable franchises, in connection with the sale of assets to Comcast and Time Warner;
- Represented the Debtors in litigation before federal and state courts, the FCC, state public utility commissions and local franchising authorities, and, when necessary, taken appeals therefrom;
- Assisted the Debtors with strategic planning and analysis related to its operations and provision of cable television and other communications services;
- Assisted the Debtors in analyzing regulatory obligations and addressing related compliance issues; and

- Assisted in pending and ongoing matters as authorized by the Debtors in the ordinary course of business, including, without limitation, subscriber agreements, rate regulation, effective competition proceedings, mandatory carriage of broadcast signals, copyright liability issues, equal employment opportunity issues, negotiation of pole attachment contracts, executory contract issues and other regulatory and statutory compliance matters.

CRB's representation allowed Debtors to continue operations during the Chapter 11 proceeding, and helped the Debtors effect a sale of assets to Comcast, Time Warner and other purchasers.

12. **The time billed for the services and the billing rates.** The time billed and billing rates for CRB are set forth in Exhibit B hereto. The time billed by CRB was necessary to accomplish the desired objectives, and the billings rates are reasonable.

13. **Steps taken by the Final Applicant to provide services solely within their scope of employment, as prescribed by their respective retention orders.** CRB was retained as special communications counsel, and all services were within the scope of that retention.

14. **Coordination of the Final Applicant's services with those of other professionals in the Adelphia Case to limit or prevent duplication of work being done.** CRB was in regular communication with Maria Arias, Tom Carlock, Greg Cannon, Kathy Hutton, Leslie Brown, Nancy Murphy, and Andy Elson at Adelphia to ensure that the Debtors stayed apprised of the work undertaken by CRB, and to ensure that services were not duplicated. Through regular communication with lawyers at Adelphia, CRB was able to prevent any significant duplication of effort and to accomplish tasks in the most efficient manner possible.

15. **Whether the services were necessary to the administration of, or beneficial at the time at which the services were rendered.** The services provided by CRB allowed Adelphia to protect its crucial assets and continue with its normal course of business during the bankruptcy, by allowing it to assure the operation of its cable television systems was in compliance with its franchises and with federal, state and local regulations. The services

provided by CRB in connection with the transfer of cable television franchises and FCC licenses was necessary to permit the sale of assets which raised funds with which to pay creditors. Ultimately, the transfer of cable television franchises was an integral part of the sale to Comcast and Time Warner

16. **Whether the services were performed within a reasonable amount of time commensurate with the complexity, importance and nature of the problem, issue or task addressed.** CRB provided timely service on all matters for which it was engaged. During the pendency of the bankruptcy, CRB, working closely with Adelphia in-house staff, made sure that the legal services provided were only those necessary for the maintenance and improvement of Adelphia's assets. During the process of selling assets, including the sale to Comcast and Time Warner, CRB worked within tight time frames to ensure the transfer of cable franchises, FCC licenses and other assets.

17. **The opposition encountered and the problems that arose.** Issues surrounding Adelphia's prior performance under various governmental authorizations raised a host of regulatory issues, which certain regulatory authorities (particularly local franchising authorities) were interested in exploring and/or exploiting. Bankruptcy also posed myriad issues under various governmental authorizations. This backdrop made it particularly difficult to navigate the already challenging regulatory environment faced by any large cable television operator.

18. **Compliance with Fee Committee Memorandum.** CRB has made a diligent attempt to comply with the Fee Committee Memorandum, and believes that it has done so.

19. **Any amounts by which the fees of the Final Applicant have been reduced voluntarily, with respect to an Interim Application or otherwise, prior to their submission to or review by the Fee Committee identified by work code or, if none, by description.** CRB



has voluntarily reduced the amounts of fees for which it seeks reimbursement. Although CRB believes that its billing rates are reasonable and its efforts on Adelphia's behalf were necessary and efficiently performed, CRB voluntarily provided Adelphia with a 10% discount with respect to all work performed. CRB on occasion voluntarily made additional reductions if the responsible attorneys had any concerns regarding the efficiency of the legal effort. All such voluntary reductions were undertaken prior to submission to or review by the Fee Committee.

20. **Any amounts by which the fees of the Final Applicant have been reduced at the recommendation of the Fee Committee, with respect to an Interim Application or otherwise, identified by work code or, if none, by description.** CRB reduced its fees by an aggregate of \$47,148.00 at the recommendation of the Fee Committee with respect to the Interim Applications.

21. **Any amounts by which the expenses of the Final Applicant have been reduced voluntarily, with respect to an Interim Application or otherwise, prior to their submission to or review by the Fee Committee identified by expense category.** CRB has not voluntarily reduced the amount of expenses for which it seeks reimbursement. These expenses were necessary expenses incurred in the course of CRB's representation of the Debtors. Included in the expenses were advances of significant amounts for filing fees in connection with cable television franchises and FCC licenses.

22. **Any amounts by which the expenses of the Final Applicant have been reduced at the recommendation of the Fee Committee, with respect to an Interim Application or otherwise, identified by expense category.** To our knowledge, the Fee Committee has not recommended a reduction of CRB's expenses with respect to an Interim Application or otherwise.

23. **Any other matters that the Fee Committee believes should be considered by the Bankruptcy Court in its final determination of compensation and expense reimbursement for the Final Applicant.** CRB believes that Adelphia received excellent value for the services provided by CRB. Services were provided efficiently and effectively and the fees were reasonable.

#### **CRB's REQUEST FOR FINAL COMPENSATION**

24. The allowance of interim compensation for services rendered and reimbursement of expenses incurred in bankruptcy cases is expressly provided for in section 331 of the Bankruptcy Code:

[A] debtor's attorney, or any professional person...may apply to the court not more than one every 120 days after an order for relief in a case under this title, or more often if the court permits, for such compensation for services rendered...as is provided under section 330 of this title.

11 U.S.C. § 331.

25. Concerning the level of compensation, section 330(a)(1) of the Bankruptcy Code provides, in pertinent part, that the court may award to a professional person, including the debtor's attorney:

...reasonable compensation for actual, necessary services rendered by the...professional person, or attorney....

11 U.S.C. § 330. The Congressional intent and policy expressed in section 330 of the Bankruptcy code is to provide for adequate compensation to continue to attract qualified and competent practitioners to bankruptcy cases.

26. CRB submits that its request for final allowance of compensation is reasonable. CRB undertook only those activities directed and authorized by Debtors. CRB has expeditiously

and effectively responded to a number of requests by Debtors for legal assistance during the Final Application Period. The services rendered by CRB required substantial time and effort and, in the bankruptcy context, are characterized by a high degree of novelty, and to a large degree, complexity. Many of CRB's services involved matters of first impression in the increasingly competitive cable television multi-channel video and telecommunications environment. The services rendered by CRB during the Final Application Period were performed diligently and efficiently. Accordingly, CRB delegated tasks to attorneys with specialized expertise in the particular task at issue. In doing so, CRB, however, sought to utilize the most cost and time efficient means available, consistent with achieving the desired goals. Where possible, junior, lower rate associates and/or paraprofessionals were utilized. CRB was able to accomplish many of the tasks more efficiently, even despite their novel and complex nature, because of its active experience with the core businesses of the Debtors, the relevant industries and the government institutions that oversee and regulate them.

27. CRB has been faced with the normal and usual time deadlines governed by FCC rules, local franchising authorities, orders or by courts in proceedings CRB is handling for the Debtors.

28. CRB's fee is neither fixed or contingent. It is based upon the actual number of hours worked (less hours written off) plus the actual costs incurred. Additionally, CRB has agreed that while acting as Special Counsel, it would provide Debtors with a ten percent discount for hourly fees. The services rendered to the Debtors by CRB during the Final Application Period required an aggregate expenditure of 25,182.5 recorded hours of the time of attorneys and paraprofessionals. Exhibit B sets forth a list of such individuals, the aggregate amount of time expended by each.

29. CRB incurred actual and necessary out-of-pocket during the Final Application Period, in connection with the rendition of the professional services described above, in the amounts set forth in Exhibit C.<sup>2</sup>

30. The disbursements for which CRB seeks reimbursement include the following:

a. Duplicating. Charged at \$0.10 per page for May 2003 through December 2006. The charge per page includes a charge for maintaining the duplicating facilities;

b. Telecommunications. Long distance calls are billed at actual cost. Outgoing domestic facsimile transmittals are billed at \$1.00 per page, while there is no charge for incoming facsimiles. This rate is based upon costs incurred by CRB for machine maintenance, phone line rental and supplies used in operating the fax machine;

c. Computer Research Charges. CRB's practice is to bill clients for LEXIS and Westlaw research at actual cost, which does not include amortization for maintenance and equipment;

d. Overtime Expenses. CRB's practice is to allow any employee working over a 9.5 hrs/day to charge a working meal to the appropriate client. The meal charge is limited to \$20 per person;

e. Local Car Service. CRB's practice is to allow attorneys, paraprofessionals and secretaries to charge car service to the appropriate client after 8:00 p.m.; and

f. Delivery Services. CRB's practice is to charge postal, overnight delivery and courier services at actual costs; and

31. As this Final Application presents no novel issue of law, CRB requests that the Court dispense with the requirement of Local Bankruptcy Rule 9013-1(b) that a memorandum of law be submitted herewith.

**CONCLUSION**


WHEREFORE, CRB respectfully requests that this Court enter an order awarding CRB:
