ORDER APPROVING FINAL APPLICATION FOR ALLOWANCE OF FEES AND EXPENSES OF GOWLING LAFLEUR HENDERSON LLP AS CANADIAN COUNSEL TO THE REORGANIZED DEBTORS FOR THE PERIOD FROM AUGUST 1, 2005 THROUGH MAY 18, 2007

This matter came before the Court on December 12, 2007 on the Final Application for Allowance of Fees and Expenses (the "Final Application") filed by Gowling Lafleur Henderson LLP ("Gowlings"), Canadian counsel to Allied Holdings, Inc. and its affiliated reorganized debtors and debtors-in-possession (collectively, the "Reorganized Debtors") for the period from August 1, 2005 through May 18, 2007 (the "Final Application Period"). The Final Application sought Cdn \$991,357.35 in professional fees and Cdn \$40,535.41 in expenses as well as Cdn \$65,573.02 in incurred taxes. Notice of the Final Application has been provided to those entities on the Master Service List (as such term is defined in the Order Establishing Notice

Procedures entered on August 2, 2005 in these jointly administered cases); no further notice is necessary. There were no objections to the Final Application filed. The Court has considered the Final Application and the matters reflected in the record of the hearing held on the Final Application. The Court finds that the requested compensation and reimbursement of expenses (including taxes) are reasonable and necessary expenses of the administration of the case. Therefore, it is hereby

- 1. ORDERED that the Application is GRANTED; and it is hereby further
- 2. ORDERED that Gowlings' request for allowance of compensation for professional services rendered during the Final Application Period of \$991,357.35<sup>2</sup> and reimbursement of expenses incurred during the Final Application Period of \$40,535.41 are hereby approved, for an aggregate final award, inclusive of taxes, of \$1,098,734.88; and it is hereby further
- 3. ORDERED that Debtors are hereby authorized to pay Gowlings the forgoing approved fees, expenses and taxes to the extent not previously paid; and it is hereby further
- 4. ORDERED that the Court shall retain jurisdiction to hear and determine all matters arising from the implementation of this Order; and it is hereby further
- 5. ORDERED that Counsel for the Debtors is directed to cause a copy of this Order to be served upon the Office of the United States Trustee, counsel for the Teamsters National Automobile Industry Negotiating Committee, counsel for Yucaipa American Alliance Fund I, LP and Yucaipa American Alliance (Parallel) Fund I, LP, counsel for Goldman Sachs
