**ORDER APPROVING SECOND INTERIM AND FINAL FEE APPLICATION FOR
ALLOWANCE OF COMPENSATION AND REIMBURSEMENT OF ITEMIZED
CHARGES AND OTHER EXPENSES TO WEINBERG, WHEELER, HUDGINS, GUNN
& DIAL, LLC, AS DEFENSE COUNSEL FOR THE REORGANIZED DEBTORS, FOR
THE PERIOD FROM AUGUST 1, 2005 THROUGH MAY 18, 2007**

This matter came before the Court on September 26, 2007 on the Second Interim and Final Fee Application for Allowance of Compensation and Payment of Itemized Charges and Other Expenses to Weinberg, Wheeler, Hudgins, Gunn & Dial, LLP (“**WWHGD**”) as defense counsel for Allied Systems, Ltd., one of the reorganized debtors and previous debtor and debtor-in-possession in the above-captioned Chapter 11 cases (the “**Reorganized Debtors**”)¹ for the period from August 1, 2005 through May 18, 2007 (the “**Application**”). The Application sought allowance of compensation in the amount of **\$83,332.00** and reimbursement of expenses in the amount of **\$10,664.71** for the period from December 1, 2006 through May 18, 2007 (the “**Interim Compensation Period**”) and final allowance of compensation in the amount of **\$178,209.00** and reimbursement of expense in the amount of **\$18,974.55** for the period from August 1, 2005 through May 18, 2007 (the “**Application Period**”).

Notice of the Application has been provided to the Office of the United States Trustee, Yucaipa, TNATINC, and the DIP Lenders (as such terms are defined by the Confirmation Order) and no further notice is necessary. There were no objections to the Application filed and no party appeared at the hearing in opposition of the Application. The Court finds that the requested compensation and reimbursement of expenses are reasonable and necessary expenses of the administration of the case. Therefore, it is hereby

ORDERED that the Application is APPROVED; and it is hereby further

ORDERED that for legal services provided by WWHGD to the Reorganized Debtors for the Interim Compensation Period, compensation in the amount of **\$83,332.00** and reimbursement of expenses in the amount of **\$8,309.84** is ALLOWED as an administrative expense claim in favor of WWHGD such that the total amount of the allowed compensation and reimbursement of expenses to WWHGD for the Interim Compensation Period is **\$91,641.84**; and it is hereby further

ORDERED that for legal services provided by WWHGD to the Reorganized Debtors for the Application Period, compensation in the amount of **\$178,209.00** and reimbursement of expenses in the amount of **\$18,974.55** is ALLOWED as an administrative expense claim in favor of WWHGD on a final basis. The total amount of the allowed compensation and reimbursement of expenses to WWHGD for the Application Period is **\$197,183.55**; and it is hereby further

ORDERED that the Court shall retain jurisdiction to hear and determine all matters arising from the implementation of this Order; and it is hereby further


