AGREED ORDER RE: FINAL APPLICATION OF HUNTLEY FINANCIAL GROUP, LTD., REAL ESTATE CONSULTANT TO THE DEBTORS FOR APPROVAL OF COMPENSATION AND REIMBURSEMENT OF EXPENSES

The "Final Application Of Huntley Financial Group, Ltd., Real Estate Consultant To The Debtors For Approval Of Compensation And Reimbursement Of Expenses" (the "Huntley Fee Application") filed by Huntley Financial Group, Inc. ("Huntley") came on for final hearing before the undersigned in his Courtroom 6, 2929 N. Central Avenue, 10th Floor, Phoenix, Arizona 85067-4151 at 11:00 a.m. on June 14, 2000. Appearances are reflected in the record. Written objections to the Huntley Fee Application were filed by General Electric Capital Corporation, Bank of America, N.A. and Gerald K. Smith, the Plan Trustee for the Boston Chicken estates, and a reply was filed by Huntley.

This Court, having considered the Huntley Fee Application and the opposition and supporting papers filed in connection therewith and the arguments of counsel at the June 14, 2000 hearing, and based on the findings of fact stated on the record at the hearing, and good cause appearing, NOW THEREFORE,

IT IS ORDERED, THAT:

- 1. The "Fees-Monthly" in the amount of \$180,000, which have already been paid in full by the Debtors, are allowed in full;
- 2. The "Fees-Lease Restructures" in the amount of \$380,755, of which \$190,377 have already been paid in full, are allowed in full;
- 3. No decision was made at the hearing with respect to the requested "Fees-Claim Negotiations-Cash Proceeds" in the amount of \$16,723 (all of which had already been paid by the Debtors), pending the parties' efforts to resolve the objections with respect thereto. By their execution of this Order, Huntley and the objecting parties stipulate and agree, and it is hereby ordered, that the final allowed amount of Huntley's fees with respect to this item shall be \$11,023.20;
- 4. The requested "Fees-Claim Negotiations-Claim Avoidance" in the amount of \$271,684 are not allowed, and pursuant to the agreement of the objecting parties at the hearing, the final allowed amount of such fees shall be \$1,350; and
- 5. The "Costs Relating to Final Fee Application Period" in the amount of \$86,251, which have already been paid in full by the Debtors, are allowed in full;

6. As a result of the foregoing, the final balance due to Huntley is \$186,028.20, as follows:

- 7. Gerald K. Smith is hereby authorized and directed to pay to Huntley the final balance set forth above, in the amount of \$186,028.20, upon entry of this Order.
- 8. Nothing herein is intended to limit Huntley's entitlement to fees for transactions falling within the scope of the last sentence of Paragraph 4 of the Huntley engagement letter.
- 9. Huntley's right to appeal this Order is not limited by paragraph 4 hereof.
