**ORDER APPROVING STIPULATION BY AND AMONG THE DEBTORS, THE POST-  
CONSUMMATION TRUST, THE AGENT, THE INDENTURE TRUSTEES AND THE  
CREDITORS COMMITTEE FOR FINAL ALLOWANCE AND PAYMENT OF THE  
INDENTURE TRUSTEES' FEES AND EXPENSES PURSUANT TO THE FIRST  
AMENDED JOINT PLAN OF COLLINS & AIKMAN CORPORATION AND ITS  
DEBTOR SUBSIDIARIES**

Upon the stipulation (Docket No. 8481) (the “Stipulation”) by and between the Debtors, the Post-Consummation Trust,<sup>2</sup> the Agent, the Indenture Trustees and the Creditors Committee for final allowance and payment of the Trustee Fees pursuant to the Plan; it appearing that the

relief requested is in the best interest of the Debtors' estates, their creditors and other parties in interest; and after due deliberation and sufficient cause appearing therefore, it is hereby

**ORDERED AS FOLLOWS:**

1. The Stipulation is approved.
2. The Court allows an Administrative Claim for the Senior Note Indenture Trustee and the Senior Subordinated Note Indenture Trustee in the amount of \$375,000 and \$475,000, respectively.
3. The Court authorizes and directs the Post-Consummation Trust to pay the Trustee Fees in accordance with the Stipulation and the Trustees' Fee Allocation.
3. The Post-Consummation Trust is authorized to take all actions necessary to effectuate the relief granted pursuant to this Order in accordance with the Stipulation.
4. The terms and conditions of this Order shall be immediately effective and enforceable upon its entry.
5. The Court retains jurisdiction with respect to all matters arising from or related to the implementation of this Order.
