FIFTH AND FINAL FEE APPLICATION OF PRICEWATERHOUSECOOPERS LLP FOR COMPENSATION FOR SERVICES RENDERED AND REIMBURSEMENT OF EXPENSES AS ACCOUNTANTS, AUDITORS, AND TAX ADVISORS FOR THE PERIOD FROM NOVEMBER 1, 2004 THROUGH DECEMBER 31, 2004 AND FOR THE FINAL PERIOD JUNE 29, 2003 THROUGH DECEMBER 31, 2004

PricewaterhouseCoopers LLP ("PricewaterhouseCoopers"), accountants, auditors, and tax advisors to the above-captioned debtors and debtors-in-possession (collectively, the "Debtors"), hereby files this Fifth and Final Fee Application of PricewaterhouseCoopers (the "Application") for interim allowance of compensation of \$120,659.99 for the period November 1, 2004 through December 31, 2004 (the "Compensation Period") and for final approval of compensation for professional services rendered in the amount of \$1,215,342.00 together with the reimbursement for actual and necessary expenses incurred in the amount of \$5,720.35 for the period June 29, 2003 through December 31, 2004 (the "Final Fee Period").

In support of this Application, PricewaterhouseCoopers respectfully represents as follows:

#### **BACKGROUND**

## General

- On June 29, 2003 (the "Petition Date"), the Debtors commenced their respective 1. reorganization cases by filing voluntary petitions for relief under chapter 11 of the Bankruptcy Code. The Debtors are continuing to operate their businesses and manage their properties and assets as debtors in possession.
- 2. On July 23, 2003, the Office of the United States Trustee appointed an Official Joint Committee of Unsecured Creditors (the "Committee"), and it has retained counsel in these cases.
- 3 On October 28, 2004, a Disclosure Statement and Chapter 11 Plan were filed by the Creditors' Committee, Noteholder Proponents and the Bank Term Lender Proponents. The Disclosure Statement and Chapter 11 Plan filings were amended on November 8, 2004 and November 10, 2004. A confirmation hearing has been set for December 20, 2004 to approve the Second Amended Joint Consolidating Chapter 11 Plan Proposed by the Debtors, Creditors' Committee, Noteholder Proponents and Bank Term Lender Proponents' Disclosure Statement (Docket No. 593) and the Chapter 11 Plan (Docket No. 594).

#### PricewaterhouseCoopers' Retention and Continued Disinterestedness

4 By this Court's order dated November 24, 2003, the Debtors were authorized to retain PricewaterhouseCoopers as their accountants, auditors, and tax advisors with regard to the filing and prosecution of the Chapter 11 Cases and all related matters (the "Retention Order"). The Retention Order authorizes the Debtors to compensate PricewaterhouseCoopers at PricewaterhouseCoopers' hourly rates charged for services of this type and to be reimbursed for actual and necessary out-of-pocket expenses incurred, subject to application to this Court in

accordance with the Bankruptcy Code, the Federal Rules of Bankruptcy Procedure, all applicable local rules, and orders of this Court. A copy of the Retention Order is attached as **Exhibit A**.

- 5. PricewaterhouseCoopers does not hold or represent any interest adverse to the estates, and is a disinterested person as that term is defined in section 101(14) of the Bankruptcy Code as modified by section 1107(b) of the Bankruptcy Code. PricewaterhouseCoopers has previously filed the Affidavit of Michael J. Byrne, in Support of Application to Retain PricewaterhouseCoopers LLP as Accountants, Auditors, and Tax Advisors for the Debtors under 11 U.S.C. § 327(a), (the "Affidavit").
- 6. PricewaterhouseCoopers may have in the past provided services, may currently provide services, and likely in the future will provide services to parties-in-interest in connection with matters unrelated to the Debtors and this case. In the Affidavit, PricewaterhouseCoopers disclosed its connections to parties-in-interest that it has been able to ascertain using its reasonable efforts. PricewaterhouseCoopers will update the Affidavit as necessary when PricewaterhouseCoopers becomes aware of material new information.
- 7. PricewaterhouseCoopers performed the services for which it is seeking compensation on behalf of or for the Debtors and their estates and not on behalf of any committee, creditor or other person.
- 8. PricewaterhouseCoopers has received no payment and no promises for payment from any source for services rendered or to be rendered in any capacity whatsoever in connection with the Chapter 11 Cases.
- 9. Pursuant to Fed. R. Bankr. P. 2016(b), PricewaterhouseCoopers has not shared, nor has PricewaterhouseCoopers agreed to share (a) any compensation it received or may receive

with another person or party, or (b) any compensation another person or party has received or may receive.

#### RELIEF REQUESTED AND REASONS THEREFOR

# Summary of Relief Requested

- 10. PricewaterhouseCoopers makes this Application pursuant to: (a) sections 330(a) and 331 of the Bankruptcy Code; (b) Rule 2016 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"); (c) pursuant to the Administrative Order Establishing Procedures for Compensation and Reimbursement of Professionals and Reimbursement of Committee Members dated August 21, 2003 (the "Administrative Order"); (d) the applicable provisions of the Guidelines for Applications for Compensation and Reimbursement of Expenses of Professionals adopted by the Office of the United States Trustee (the "Guidelines"); and (e) the Local Rules of Bankruptcy Practice and Procedure of the United States Bankruptcy Court for the District of Delaware (the "Local Rules").
- 11. Prior to the filing of this Application, PricewaterhouseCoopers has filed four Interim Quarterly Fee Applications. The First Interim Quarterly Fee Application was submitted on November 26, 2003, the Second Interim Quarterly Fee Application was submitted on March 31, 2004, the Third Interim Quarterly Fee Application was submitted on July 30, 2004, and the Fourth Interim Quarterly Fee Application was submitted on December 2, 2004. Subsequently, PricewaterhouseCoopers has submitted two monthly fee invoices (the "Monthly Fee Invoices") with the Court pursuant to the Administrative Order. These Monthly Fee Invoices are the subject to this Application (further discussion in Paragraphs 21 through 22 herein).
- 12. PricewaterhouseCoopers requests that the Court approve the interim allowance of compensation for professional services rendered and the reimbursement of actual and necessary

expenses incurred by PricewaterhouseCoopers from November 1, 2004 through December 31, 2004<sup>3</sup>, totalling \$120,659.99, representing \$67,397.75 in hourly services and \$53,262.24 in fixed fee services and final allowance totalling \$1,215,342.00, representing \$923,497.10 in hourly services, \$4,566.70 in final fee application, \$287,278.20 in fixed fee services and \$5,720.35 in out-of-pocket expenditures.

- 13. The detailed billing detail for the Compensation Period for which are attached hereto as: **Exhibit B**, List of Professionals Accounting, Auditing, Tax Services, and Fixed Fee Services, **Exhibit C**, Summary of Compensation by Project Category for Accounting, Auditing, Tax Services and Fixed Fee Services, Attached hereto as **Exhibit D1** through **Exhibit F2** are the monthly summary of the detailed time descriptions by category of the professional fees for accounting and auditing services, tax services and fixed fee services.
- 14. The summary of the hours, fees and expenses associated with the Final Fee Period are attached hereto as: **Exhibit G**, List of Professionals Final, **Exhibit H**, Summary of Compensation by Project Category Final, and **Exhibit I**, Summary of Expenses Final.

#### Prior Fee Applications and Payments to PricewaterhouseCoopers

15. Since the Retention Date, PricewaterhouseCoopers has filed and served the First, Second, Third and Fourth Interim Quarterly Fee Applications and Monthly Fee Invoices for interim allowance of compensation as set forth below:

#### First Interim Fee Application – June 2003 through October 2003

16. On November 26, 2003, PricewaterhouseCoopers filed the First Quarterly Interim Fee Application for the Interim Period June 29, 2003 through October 31, 2003 (the "First Quarterly Fee Application", Docket No. 252, requesting \$150,133.65 in fees and \$4,280.65 in

expenses, totalling \$154,414.30, representing the cumulative fees and expenses for the First

Quarterly Interim Fee Application by PricewaterhouseCoopers). PricewaterhouseCoopers has

received payment pursuant to the Administrative Order in the amount of \$154,414.30 (100% of

fees and 100% of expenses).

Second Interim Fee Application – November 2003 through February 2004

17. On March 31, 2004, PricewaterhouseCoopers filed the Second Quarterly Interim

Fee Application for the Interim Period November 1, 2003 through February 29, 2004 (the

"Second Quarterly Fee Application", Docket No. 373, requesting \$487,314.82 in fees and

\$1,439.70 in expenses, totalling \$488,754.52, representing the cumulative fees and expenses for

the Second PricewaterhouseCoopers). Quarterly Interim Fee Application by

PricewaterhouseCoopers has received payment pursuant to the Administrative Order in the

amount of \$488,754.52 (100% of fees and 100% of expenses).

Third Interim Fee Application – March 2004 through June 2004

On July 30, 2004, PricewaterhouseCoopers filed the Third Quarterly Interim Fee 18.

Application for the Interim Period March 1, 2004 through June 30, 2004 (the "Third Quarterly

Fee Application", Docket No. 490, requesting \$290,230.88 in fees and \$0.00 in expenses,

totalling \$290,230.88, representing the cumulative fees and expenses for the Third Quarterly

Interim Fee Application by PricewaterhouseCoopers). On September 15, 2004 the Court

approved the compensation of \$290,230.88 for services rendered by PricewaterhouseCoopers to

the Debtors. PricewaterhouseCoopers has received payment pursuant to the Administrative

Order in the amount of \$290,230.88 (100% of fees and 100% of expenses).

## <u>Fourth Interim Fee Application – July 1, 2004 through October 31, 2004</u>

19. On December 2, 2004, PricewaterhouseCoopers filed the Fourth Quarterly Interim Fee Application for the Interim Period July 1, 2004 through October 31, 2004 (the "Fourth Quarterly Fee Application", Docket No. 666, requesting \$162,435.96 in fees and \$0.00 in expenses, totalling \$162,435.96, representing the cumulative fees and expenses for the Third Quarterly Interim Fee Application by PricewaterhouseCoopers). On January 3, 2005, the Court approved the compensation of \$162,435.96 for services rendered by PricewaterhouseCoopers to the Debtors. PricewaterhouseCoopers has received payment pursuant to the Administrative Order in the amount of \$162,435.96 (100% of fees and 100% of expenses).

#### Fifth Interim Fee Application – November 1, 2004 through December 31, 2004

- 20. On December 22, 2004, PricewaterhouseCoopers filed the Monthly Fee and Expense Invoice of PricewaterhouseCoopers LLP for Compensation Interim Period November 1, 2004 through November 30, 2004 (the "November Invoice", Docket No. 727), requesting \$49,973.60 in fees (80% of \$62,466.99). The time for filing objections to the November Invoice expired on January 11, 2005. At the date of preparation of this Application, PricewaterhouseCoopers is pending payment of \$12,493.39 (20% of \$62,466.99) pursuant to the Administrative Order.
- 21. On January 25, 2005, PricewaterhouseCoopers filed the Monthly Fee and Expense Invoice of PricewaterhouseCoopers LLP for Compensation Interim Period December 1, 2004 through December 31, 2004 (the "December Invoice", Docket No. 753), requesting \$46,554.40 in fees (80% of \$58,193.00). The time for filing objections to the December Invoice expires on February 14, 2005.

#### SERVICES RENDERED BY PRICEWATERHOUSECOOPERS

22. PricewaterhouseCoopers professionals categorized their time devoted to this matter on behalf of the Debtors' estates to various project categories (the "Project Categories"). Below is a summary of the professional services performed by PricewaterhouseCoopers professionals during the Fifth Interim Compensation Period, organized by Project Categories described in Paragraphs 24 through 26 herein for the Accounting and Auditing Services, Paragraphs 27 through 31 for the Tax Services and Paragraphs 32 through 35 for Fixed Fee Services.

#### A. Accounting and Auditing Services

23. PricewaterhouseCoopers' professionals incurred 193.2 hours and \$55,263.70 in accounting and auditing services during the Compensation Period. See the detailed time descriptions attached herein as *Exhibits D1 through D2*.

## A. Monthly Invoices and Interim Fee Applications – 33.7 hours - \$6,656.20

24. During the Compensation Period, PricewaterhouseCoopers completed the preparation of the four monthly invoices (October 2004 and November 2004), the fourth interim quarterly fee application, as well as the associated ASCII files (Monthly and Interim) for submission to the Court. In January and February 2005, PricewaterhouseCoopers' professionals began preparing the exhibits and draft narrative for this Application, as well as the December 2004 invoice; these hours and fees have been added to this Final Application (17.8 hours, \$4,566.70).

#### B. Quarterly Financial Statement Review – 159.5 hours - \$48,607.50

25. PricewaterhouseCoopers professionals worked with management of the Partnership, the National Office and the local office in the execution of reviews of quarterly

financial statements on form 10-Q with the SEC. PricewaterhouseCoopers professionals performed the following tasks:

- Performed review procedures based on scoping document and standard procedures performed for quarterly reviews;
- Prepared and presented at internal communication meetings between the engagement team and the National office regarding the accounting and auditing issues at hand and formalized appropriate accounting treatment;
- Prepared, presented and discussed at external client meetings, findings during our review procedures;
- Reviewed form 10-Q filed with the SEC using National and local office staff.
- Reviewed form 8-K's filed with the SEC using National and local office staff.

#### **B.** Tax Services

26. PricewaterhouseCoopers' professionals incurred 63.4 hours and \$12,134.05 in fees for tax services. See the detailed time descriptions attached herein as *Exhibits E1 through E2*.

#### A. Monthly Invoices and Interim Fee Applications – 10.3 hours - \$1,767.25

27. During the Compensation Period, PricewaterhouseCoopers completed the preparation of the four monthly invoices (November 2004). The preparation of the December monthly invoice and the preparation of this Application occurred in 2005.

## B. Other – Bankruptcy Tax Issues – 26.6 - \$3,933.55

28. PricewaterhouseCoopers' professionals worked with management of the Partnership, the National Office and the local office to research various bankruptcy tax matters related to the potential reorganization plan.

#### C. Year End & 2004 Planning – 14.5 hours - \$3,560.50

29. PricewaterhouseCoopers professionals worked with management of the Partnership in planning for the federal and state tax returns for the Partnership for the year-ended December 31, 2004.

#### D. Quarterly Review - 12.0 hours - \$2,872.75)

*30.* PricewaterhouseCoopers professionals reviewed the Partnership's calculations concerning certain tax liabilities incurred by asset sales of four C-Corporations owned by the Partnership.

C.

#### D. Fixed Fee Services

31. PricewaterhouseCoopers provides several fixed fee services on behalf of the Debtors: Monthly Invoices and Interim Fee Applications, K-1 Processing and Nominee Bridge Services. See the detailed time descriptions attached herein as *Exhibits F1 through F2*.

#### E. Monthly Invoices and Interim Fee Applications – 2.9 hours - \$831.00

32. PricewaterhouseCoopers professionals associated with the fixed fee services prepared their December 2004 time summaries for the bankruptcy court application. The preparation of the December monthly invoice and the preparation of this Application occurred in 2005.

#### F. K-1 Processing – 182.0 hours - \$46,710.00

33. PricewaterhouseCoopers provides partnership tax accounting and reporting services for Crown Pacific Partners, L.P. These services include requirements planning, implementation and processing, K-1 processing, K-1 support, and project management.

Requirements of planning include determining the mail date for the K-1s to be sent to investors and determining all other tasks around this date. It also involves coordinating with the print vendor to modify the tax package each year for evolving tax law changes. In addition, it entails maintenance of the software/hardware for K-1 support site for continuous annual support. The implementation and processing includes the bulk of the services provided. The nominee data is moved from the Nominee Bridge into the PARSPlus software and combined with prior year data. Additionally, the transfer agent data is reviewed and posted into the PARSPlus system with prior

year data. This year the data transfer was further analyzed to verify the accuracy of reporting surrounding the termination of the dividend reinvestment plan for the partnership. Utilizing asset numbers and units outstanding, a unitized value is created for each month since partnership inception, for each reportable item on the K-1. Once this is complete, the values are merged with the shareholders information to generate K-1's. This data is sent to a print vendor, printed, inserted into envelopes, and mailed to investors. Final K-1 processing took place in July for the 2004 tax year, after investors had time to call and correct any mistakes in their holdings, through the K-1 support center.

#### B. Nominee Bridge Services - \$5,721.24

34. PricewaterhouseCoopers has been retained to represent the Debtors by performing nominee data collection services, described in para. No. 13 of the Application, provided services from October 1, 2004 through November 30, 2004 as agent for Crown Pacific Partners, L.P.

#### **CONCLUSION**

- 35. The professional services and related expenses for which PricewaterhouseCoopers requests interim allowance of compensation and reimbursement of expenses were rendered and incurred in connection with these cases in the discharge of PricewaterhouseCoopers' professional responsibilities as Accountants, Auditors, and Tax Advisors for the Debtors in these chapter 11 cases. PricewaterhouseCoopers' services have been necessary and beneficial to the Debtors, their estates, and creditors, and to other parties-in-interest.
- 36. WHEREFORE, PricewaterhouseCoopers requests that an allowance be made to PricewaterhouseCoopers in the sum of \$120,659.99 (\$67,397.75 for accounting, auditing and tax services rendered; \$53,262.24 of fixed fee services) as compensation for reasonable and necessary professional services rendered to the Debtors; and for final approval of compensation

for professional services rendered as accountants, auditors and tax advisors in the amount of \$1,215,342.00 (\$923,497.10 for accounting, auditing and tax services rendered; \$4,566.70 in final fee application preparation; \$287,278.20 of fixed fee services) together with reimbursement for actual and necessary expenses incurred in the amount of \$5,720.35 for the Final Fee Period, and that Debtors be authorized and directed to pay to PricewaterhouseCoopers the outstanding amount of such sums; and for such other and further relief as this Court deems proper.



**ORDER UNDER 11 U.S.C. §§ 327(a),** 328(a) AND 504 AND FED. R. BANKR. P. 2014 AUTHORIZING EMPLOY-MENT AND RETENTION OF **PRICEWATERHOUSECOOPERS** L.L.P. NUNC PRO TUNC AS ACCOUNTANTS, AUDITORS AND TAX ADVISORS FOR DEBTORS AND DEBTORS-IN-POSSESSION

THIS FILING APPLIES TO:



CAME ON FOR CONSIDERATION the Application for Order Authorizing the Employment of PricewaterhouseCoopers ("PWC"), *Nunc Pro Tunc*, as Debtors' Accountants, Auditors and Tax Advisors Pursuant to Sections 327(a), 328(a) and 504 of the Bankruptcy Code (the "Application") filed by the above-captioned debtors and debtors-in-possession (the "Debtors"). After considering the Application and the Statement and Declaration of PricewaterhouseCoopers L.L.P. and the Affidavit of Michael Byrne Pursuant to Bankruptcy Rule 2014 and Bankruptcy Code Sections 327, 329 and 504 (the "Byrne Affidavit"), the Court finds that (i) PWC does not represent or hold an interest adverse to the Debtors' estates with respect to the matters upon which PWC is to be engaged; (ii) PWC is quantified to act as accountants, auditors and tax advisors to the Debtors under section 327(a) of title 11 of the United States Code, 11 U.S.C. §§ 101-1330 (as amended, the "Bankruptcy Code"); (iii) PWC's employment would best serve the interests of the Debtors and their estates; and (iv) the terms of PWC's employment have been disclosed and are reasonable under the circumstances, as limited by this order. It is therefore

ORDERED that, pursuant to sections 327(a), 328(a) and 504 of the Bankruptcy Code and Bankruptcy Rule 2014, the Debtors are authorized to retain and employ PWC in the above-captioned Chapter 11 cases as the Debtors' accountants, auditors and tax advisors, *nunc pro tunc* to the Petition Date, upon the terms and conditions of the employment set forth in the Application and as modified by this order; and it is further

ORDERED that with respect to the Hourly Services, as defined in the Application, PWC (a) will only be required to maintain contemporaneous time records for Hourly Services rendered postpetition in half-hour increments with sufficient detail to identify the services performed; and (b) will file fee applications with the Court for interim and final allowance of compensation and

reimbursement of expenses pursuant to the procedures set forth in sections 330 and 331 of the Bankruptcy Code, the Bankruptcy Rules, the Local Rules of Bankruptcy Procedure for the District of Arizona, any orders of this Court, and any procedures with respect to the interim compensation of professionals which may be fixed by this Court; and it is further

ORDERED that with respect to the Fixed Fee Services, as defined in the Application, the Letter of Understanding to Provide Partnership Tax Accounting and Reporting Services is approved with the following modifications:

- (a) The Debtors may terminate the engagement of PWC under the Letter of Understanding to Provide Partnership Tax Accounting and Reporting Services upon thirty (30) days written notice. If Debtors terminate the engagement of PWC under the Letter of Understanding to Provide Partnership Tax Accounting and Reporting Services, PWC shall prepare a final bill for the Fixed Fee Services performed until the effective date of termination of the engagement. The Debtors shall pay, subject to Bankruptcy Court approval, the undisputed fees and expenses for the Fixed Fee Services to PWC, and shall not be liable for any damages for breach of the Letter of Understanding to Provide Partnership Tax Accounting and Reporting Services; and
- (b) PWC shall only be required to maintain contemporaneous time records for Fixed Fee Services rendered postpetition in half-hour increments with sufficient detail to identity the services performed and shall not be required to provide or conform to any schedule of hourly rates;

and it is further

ORDERED that with respect to the Fixed Fee Services, PWC will file fee applications with the Court for interim and final allowance of compensation and reimbursement of expenses pursuant to the procedures set forth in sections 330 and 331 of the Bankruptcy Code, the Bankruptcy Rules, the Local Rules of Bankruptcy Procedure for the District of Arizona, any orders of this Court, and any procedures with respect to the interim compensation of professionals which may be fixed by this Court; and it is further

ORDERED that, notwithstanding the foregoing, compensation and reimbursement for the Fixed Fee Services shall be subject to objection by parties in interest pursuant to the standards set forth in sections 328(a) and 330 of the Bankruptcy Code when interim and final fee applications are filed; and it is further

ORDERED that the Dispute Resolution Procedures attached as Exhibit B to the Application are hereby approved; and it is further

ORDERED that the Debtors shall coordinate and direct the services to be performed by PWC and the other professionals retained by the Debtors to avoid the duplication of professional services, and PWC shall not provide services to the Debtors which are duplicative of services provided by other professionals in these Chapter 11 cases; and it is further

ORDERED that the Debtors shall give notice of the terms and effect of this Order by mailing a copy of this Order to the parties on the Official Service List; and it is further

ORDERED that any objection by any party that PWC is precluded from acting as the Debtor's accountants, auditors and tax advisors in these Chapter 11 cases under section 327(a) of the Bankruptcy Code that arises from a connection disclosed in the Byrne Affidavit shall be made within fifteen (15) days of service of this Order; and it is further

ORDERED that this Court shall retain jurisdiction to hear and determine all matters arising from the implementation of this Order.
