FOURTH AND FINAL APPLICATION OF WILSON, ELSER, MOSKOWITZ, EDELMAN & DICKER LLP FOR AWARD OF COMPENSATION FOR PROFESSIONAL SERVICES RENDERED AND REIMBURSEMENT OF EXPENSES INCURRED

COMES NOW, Wilson, Elser, Moskowitz, Edelman & Dicker LLP ("Wilson Elser" or "Applicant"), Local Co-Counsel for the Official Section 1114 Committee of Retired Pilots (the "Retired Pilots Committee"), as and for its fourth and final application for allowance of compensation for professional services (the "Application") performed by Wilson Elser for the period of February 1, 2007 through March 31, 2007 (the "Compensation Period"), plus final approval of all fees and expenses previously approved and paid from March 30, 2006 through January 31, 2007, in connection with the above captioned bankruptcy cases as follows: (i) interim and final approval and allowance of its actual and necessary fees incurred during the Compensation Period in the amount of \$14,012.50; (ii) interim and final approval and allowance of its actual and necessary expenses incurred during the Compensation Period in the amount of

\$174.33; (iii) authorization pay the 20% holdback of fees during the Compensation Period of \$2,802.50; and (iv) final approval of fees and expenses previously approved and paid on an interim basis from March 30, 2006 through January 31, 2007 in the amount of \$121,107.50 (fees) and \$7142,18 (expenses), respectively. Wilson Elser files this Application pursuant to Sections 330 and 331 of the Bankruptcy Code (the "Bankruptcy Code"), Rule 2016(a) of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), and the Order Pursuant to Sections 105(a) and 331 of the Bankruptcy Code and Bankruptcy Rule 2016(a) to Establish Procedures for Interim Monthly Compensation and Reimbursement of Expenses of Professionals, dated October 6, 2005 (the "Compensation and Reimbursement Order"). The amount sought for fees during the Compensation Period represents approximately 34.80 hours of professional services. In support of this Application, Wilson Elser shows the Court the following:

#### **JURISDICTION**

1. The Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334. Venue is proper pursuant to 28 U.S.C. §§ 1408 and 1409. This is a core proceeding pursuant to 28 U.S.C. § 157(b)(2). Venue of this case is proper in this district pursuant to 28 U.S.C. §§ 1408 and 1409, respectively. This Application requests relief pursuant to Sections 330, 331, 1103 and 1114 of the Bankruptcy Code.

#### **BACKGROUND**

- 2. On September 14, 2005 (the "Petition Date"), the Debtors filed voluntary petitions for relief under chapter 11 of Bankruptcy Code.
- 3. On October 6, 2005, this Court entered the Compensation and Reimbursement Order. The Compensation and Reimbursement Order authorized professionals paid from the Debtors' bankruptcy estates to serve monthly fee statements, by hand or overnight delivery,

seeking payment for services rendered and for out-of-pocket expenses or other charges incurred on or before the 20<sup>th</sup> day of each month following the month for which compensation is sought on (i) Delta Air Lines, Inc.; (ii) counsel for the Debtors, Davis Polk & Wardwell; (iii) counsel for the Official Committee of unsecured Creditors, Akin Gump Strauss Hauer & Feld LLP; (iv) counsel to the Official Section 1114 Committee, Foley & Lardner; (v) the Office of the United States Trustee for the Southern District of New York; (vi) counsel for the Official Section 1114 Committee of Retired Pilots, Stinson Morrison Hecker LLP ("SMH"); and (vii) counsel for any other official committee appointed by the Court. The Compensation and Reimbursement Order authorized the Debtors to pay Professionals 80% of fees requested and 100% of expenses identified in each Monthly Fee Statement.

- 4. On March 17, 2006, this Court entered an Order approving the report of the United States Trustee regarding the solicitation process for forming an official committee to represent the retired pilot employees of the Debtors, and their spouses and dependents (the "Retired Pilots"). The Retired Pilots Committee currently consists of nine members. The Retired Pilots Committee has selected the law firm SMH to serve as its lead counsel, and Wilson Elser to serve as local co-counsel to represent the interest of the Retired Pilots Committee and its constituent members pursuant to section 1114 of the Bankruptcy Code.
- 5. On May 1, 2006, this Court entered an Order Authorizing the Employment and Retention of SMH and Wilson Elser as Attorneys to the Retired Pilots Committee Pursuant to 11 U.S.C. § 1114.

#### **OVERVIEW OF COMPENSATION SOUGHT**

6. Wilson Elser served its Monthly Fee Statements in accordance with the Compensation and Reimbursement Order and no objections were filed. In accordance with the

Compensation and Reimbursement Order, Wilson Elser expects to receive, 80% of its incurred fees and 100% of its incurred expenses requested in its Monthly Fee Statements, representing \$14,012.50 (\$13,847.50 in fees and \$165.00 in expenses) as compensation and reimbursement of expenses for February 1, 2007 through March 31, 2007. Wilson Elser currently has an outstanding balance, as of the date of this Application of \$2,802.50 representing the 20% holdback of fees during the Compensation Period. Wilson Elser also seeks final approval of the fees and expenses previously approved and paid on an interim basis from March 30, 2006 through January 31, 2007 in the amount of \$121,107.50 (fees) and \$7142,18 (expenses), respectively.

#### WILSON ELSER'S APPLICATION

- 7. In accordance with Sections 330 and 331 of the Bankruptcy Code, Bankruptcy Rule 2016, and the Compensation and Reimbursement Order, Wilson Elser seeks interim and final approval of the fees and expenses set forth above for the Compensation Period, and final approval for the previously approved interim fees and expenses.
- 8. Under Section 330 of the Bankruptcy Code, the Court may allow compensation and reimbursement of Wilson Elser's expenses only after notice and a hearing. Bankruptcy Rule 2002(a)(6) provides that hearings on applications for compensation and reimbursement of expenses totaling in excess of \$1,000 must be on 20-days notice to parties in interest. Section 331 of the Bankruptcy Code authorizes the filing of interim fee applications. This Application is the third such application made by Wilson Elser under Section 331 of the Bankruptcy Code.
- 9. This Application complies with the Amended Guidelines for Fees and Disbursements of Professionals in the Southern District of New York Bankruptcy Cases, adopted by the court on April 19, 1995 (the "Local Guidelines"), the United Trustee Guidelines for

Reviewing Applications for Compensation and Reimbursement of Expenses Filed under 11 U.S.C. § 330, adopted on January 30, 1996 (the "UST Guidelines"), and the Compensation Order. A certification of compliance with the Local and UST Guidelines and Compensation Order is attached as Exhibit "A."

- 10. All legal services performed by Wilson Elser were performed for and solely on behalf of the Retired Pilots Committee, and not on behalf of any other committee, creditor, or other person or entity.
- 11. The following is a brief summary of the qualifications of each Wilson Elser professional representing the Debtors for which compensation is sought:

#### Attorneys:

Mark G. Ledwin: Mark Ledwin is a partner with the law firm of Wilson Elser, practicing since 1990, who has experience in bankruptcy matters.

<u>David L. Tillem</u>: David Tillem is a partner with the law firm of Wilson Elser, practicing since 1980, who has experience in bankruptcy matters.

Greg A. Friedman: Greg Friedman is an associate with the law firm of Wilson Elser, practicing since 2004, who has experience in bankruptcy matters.

#### **SUMMARY OF SERVICES RENDERED**

#### A. Case Administration

12. Included in this category is time devoted to various functions that Wilson Elser has performed in its capacity as local counsel to efficiently monitor this chapter 11 case, such as preparing for and attending hearings and committee meetings, reviewing various pleadings, motions and communications, and communicating the status of the case to the Retired Pilots Committee and its professionals.

#### B. Employment Applications

13. Included in this category is time devoted to preparing all applications for employment and retention on behalf of the Retired Pilots Committee and its professionals in this case and analyzing and responding to a variety of issues raised by parties related to the applications and formation of the Retired Pilots Committee generally and the retention of its professionals. Wilson Elser helped prepare and review the application for employment and retention of the financial advisers and actuaries for the Retired Pilots Committee. Also included in this category are meetings and various communications with lead counsel and other professionals.

#### C. <u>Litigation, Settlement and Plan Negotiations</u>

15. Included in this category is time devoted to handling various court filings and reviewing various procedural rules to ensure compliance. Also included in this category is significant time devoted to the analysis and negotiation of a successful resolution with the Debtors of certain Section 1114 issues for the Retired Pilots Committee which was ultimately incorporated into the Debtors' confirmed plan of reorganization.

#### STATUTORY BASIS FOR COMPENSATION

16. Sections 330 and 331 of the Bankruptcy Code form the statutory basis for compensation of professionals in bankruptcy cases. Section 330 provides that a court may award a professional employed under Section 327 of the Bankruptcy Code "reasonable compensation for actual, necessary services rendered ... and reimbursement for actual, necessary expenses." 11 U.S.C. § 330(a)(1). Section 330 also sets forth the criteria for the award of such compensation and reimbursement.

In determining the amount of reasonable compensation to be awarded, the court shall consider the nature, the extent, and the value of such services, taking into account all relevant factors including –

- (A) the time spent on such services;
- (B) the rates charged for such services;
- (C) whether the services were necessary to the administration of, or beneficial at the time at which the service was rendered toward the completion of, a case under this title;
- (D) whether the services were performed within a reasonable amount of time commensurate with the complexity, importance and nature of the problem, issue, or task addressed; and
- (E) whether the compensation is reasonable based on the customary compensations charged by comparatively skilled practitioners in cases other than cases under this title.

11 U.S.C. § 330(a)(3). Pursuant to Section 331 of the Bankruptcy Code, the Court may authorize interim compensation for professional services. 11 U.S.C. § 331.

- 17. The Bankruptcy Code provisions concerning the compensation of professionals are designed to ensure that qualified attorneys will be compensated for services rendered to the debtors at a market rate for comparable services rendered in non-bankruptcy cases. <u>In re Ames Dep't Stores, Inc.</u>, 76 F.3d 66, 71 (2d Cir. 1996). The rationale behind this goal is to ensure that counsel will not be deterred from taking bankruptcy cases due to failure to pay adequate compensation.
- 18. Wilson Elser has rendered substantial and valuable services on behalf of the Retired Pilots Committee that have resulted in a significant benefit to the Debtors' estate, and its creditors, and which were beneficial to the administration of the chapter 11 case. Wilson Elser respectfully submits that its services were provided with the requisite level of skill and were performed within a reasonable amount of time commensurate with the complexity, importance, and nature of problems, issues, and tasks addressed. Wilson Elser has charged its customary fees, which are reasonable based on the customary compensation charged by comparably skilled

practitioners in cases other than cases under this title. The amount sought in compensation is in line with awards in similar cases and is commensurate with the professional standing, ability and expertise of Wilson Elser and the professionals who have participated in this case. Accordingly, the compensation requested herein reflects the reasonable value of the services provided to the Retired Pilots Committee.

19. Attached hereto as Exhibit "B" are the Monthly Fee Statements detailing the fees that Wilson Elser actually charged during the Compensation Period, corresponding to the categories detailed above. In accordance with Bankruptcy Rule 2016(a), the itemized list identifies: (a) the specific tasks performed; (b) the attorney who performed them; (c) the time required to perform them; (d) the date on which the tasks were performed. To the extent possible, Wilson Elser has described each specific task and separately allocated the time attributable to that task. Where the nature of certain tasks and the circumstances surrounding their performance did not allow for individual time entries, aggregate time entries were used.

#### **REIMBURSEMENT OF EXPENSES**

20. Pursuant to § 330(a)(1)(B) of the Bankruptcy Code, the Court may award a professional "reimbursement for actual, necessary expenses." 11 U.S.C. § 330(a)(1)(B). Accordingly, Wilson Elser seeks reimbursement of the actual, necessary expenses that it incurred during the course of providing legal services to the Retired Pilots Committee. Wilson Elser typically charges its clients \$0.20 per page for copies. Charges for travel, overnight delivery, postage, long distance phone calls, and other out-of-pocket disbursements are based on actual amounts paid by Wilson Elser for those services. A detailed description of the actual and necessary expenses that Wilson Elser incurred during the Compensation Period is included on the Monthly Fee Statements attached hereto as Exhibit B.

**MEMORANDUM OF LAW** 

21. Wilson Elser submits that it has complied with the requirement of Local

Bankruptcy Rule 9013-1 to file a memorandum of law in support of this Application given that

the relevant legal authorities are set forth herein.

**CONCLUSION** 

22. As the foregoing Application and the attached Exhibits demonstrate, Wilson Elser

is entitled to interim and final approval of compensation in the amount of \$135,120.00 for its

professional services, and \$7,316.51 for actual and necessary expenses.

WHEREFORE, Wilson Elser respectfully requests that this Court enter an Order granting

its Fourth and Final Fee Application.
