#### **Estate Management Activities**

- Negotiated settlement of commercial claims with Verizon. Amounts claimed by Verizon exceeded \$260 million and amounts due to Genuity from Verizon exceeded \$90 million. Resolve dispute resulting in payment Genuity of \$25.2 million and reduction of Verizon's unsecured claim \$174 million.
- Negotiated and settled various large vendor disputes including receipts from AOL for \$2.5 million. Resolved cure dispute with Cisco for \$6 million claim payment (\$8 million decrease) and Level 3 for \$35 million Purchase Price Adjustment settlement and \$305K administrative claim.
- Assisted Genuity management and outside counsel in reconciling vendor objections to cure amounts. Prepared settlement analysis and proposed settlement offers to Level 3, Time Warner Telecom and Americas II.
