EXPENSES FOR THE FINAL INTERIM PERIOD

Your Applicant, Eric A. Browndorf, Esquire respectfully represents that:

1. Your Applicant is a partner of the law firm of Cooper Perskie April Niedelman Wagenheim & Levenson, PA, (hereinafter "Cooper Perskie") attorneys for the Official

- 2. The Debtor's Chapter 11 petition was filed January 5, 1998.
- 3. By Order of Court Cooper Perskie was appointed to represent the Committee Nunc Pro
 Tunc to January 13, 1998, a copy of which is annexed hereto as Exhibit "A".
- 4. Your Applicant and other attorneys in this law firm have performed all of the necessary legal services required since the time of employment up to and including the present time.
- 5. In the performance of these duties, your Applicant and other attorneys in his law firm performed services as set forth in the Detailed Description of Professional Services Rendered, Time Expended and Expenses Incurred, all of which are annexed to the Application filed herewith.
- 6. Your Applicant represents that, in his opinion, a fair and reasonable, usual and customary attorney fee in this community for services similar to those performed by him and other members of the firm's above-mentioned attorneys with their experience at the Bar is the sum of \$1,251,829.84 for services performed for the period from January 13, 1998 through and including September 29, 2000.
