OMNIBUS ORDER: (1) GRANTING THE FINAL FEE APPLICATIONS FOR PROFESSIONALS OF THE DEBTORS AND OF THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS, AND (2) GRANTING THE FINAL EXPENSE APPLICATION FOR THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS

[Re: Docket Nos. 5307, 5304, 5335, 5271, 5306, 5299, 5296, 5280, 5288, 5289, 5297, 5303 (for Professionals) and Docket No. 5341 (for Committee)]

Professionals of the captioned debtors and debtors in possession (the "Debtors") and professionals of the Official Committee of Unsecured Creditors (the "Committee") have filed final applications for allowance of compensation and reimbursement of expenses (the "Final Fee Applications"). Members of the Committee have filed a final application for allowance of the Committee's expenses (the "Final Committee Expense Application"). The Final Fee Applications and the Final Committee Expense Application (collectively, the "Final Applications") are set forth with more particularity on Exhibit A attached hereto. The Court has reviewed the Final Applications and finds as follows: (a) that the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; (b) that notice of the Final Applications in the

amounts and for the periods set forth on Exhibit A, and notice of the hearing on the Final

Applications, was adequate under the circumstances; (c) that the fees and expenses as set forth

on Exhibit A were actual, reasonable, and necessary; and (d) that all persons with standing have

been afforded the opportunity to be heard on the Final Applications.

Accordingly, it is hereby

ORDERED that the Final Applications listed on Exhibit A are approved, and it is

further

ORDERED that fees in the amounts, as set forth with more particularity on

Exhibit A, as compensation for actual, reasonable, and necessary professional services rendered

are hereby allowed on a final basis, and it is further

ORDERED that costs and expenses, as set forth more particularity on Exhibit A,

as actual, reasonable, and necessary costs and expenses are hereby allowed on a final basis; and

it is further

ORDERED that the Debtors shall pay each professional any outstanding amounts

due on the Final Applications.
