**ORDER GRANTING FINAL APPLICATION FOR COMPENSATION AND REIMBURSEMENT OF EXPENSES OF WILLIAMS MULLEN CLARK & DOBBINS, P.C., SPECIAL COUNSEL FOR THE DEBTORS**

Williams Mullen & Dobbins, P.C. ("WILLIAMS MULLEN"), as special counsel for the debtors and debtors in possession, filed a final application for allowance of compensation and reimbursement of expenses for October 1, 2001 through November 21, 2002 (the "Final Application"). The Court has reviewed the Final Application and finds that: (a) the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; (b) notice of the Final Application, and any hearing on the Final Application, was adequate under the circumstances; and (c) all persons with standing have been afforded the opportunity to be heard on the Final Application. Accordingly, it is hereby

ORDERED that the Final Application is GRANTED, on a final basis. The Court allows and authorizes on a final basis the sum of \$81,593.00 as compensation and \$2,403.73 as

reimbursement of expenses, for a total of \$83,996.73 for services rendered and disbursements incurred by WILLIAMS MULLEN for the period October 1, 2001 through November 21, 2002, less amounts previously paid. WILLIAMS MULLEN shall have an administrative claim for the unpaid portion of such sums.

ORDERED that to the extent WILLIAMS MULLEN has incurred fees and expenses in addition to the foregoing, WILLIAMS MULLEN may file and serve a supplemental fee application and submit a certificate of no objection and order to the Court for final approval of such fees and expenses as may be reflected in any supplemental fee application.
