**FINAL APPLICATION OF THE OFFICIAL COMMITTEE OF UNSECURED
CREDITORS OF PREMIERE ASSOCIATES, INC. AND ITS SUBSIDIARIES FOR
APPROVAL OF REIMBURSEMENT OF COMMITTEE MEMBER EXPENSES FOR
THE PERIOD FROM JANUARY 4, 2002 THROUGH MAY 12, 2003**

By this application (the “Final Application”), the Official Committee of Unsecured Creditors of Premiere Associates, Inc. and its Subsidiaries (the “Premiere Committee”), by and through its undersigned attorneys, hereby seeks final approval of all interim applications filed by the Premiere Committee in these cases for reimbursement of actual and necessary Premiere Committee member expenses incurred in the amount of \$15,949.96, for the period January 4, 2002 through May 12, 2003 (the “Final Period”). In support of this Final Application, the Premiere Committee respectfully represents as follows:

1. On February 2, 2000, Integrated Health Services, Inc., et al. (collectively, the “Debtors”) filed voluntary petitions for reorganization under Chapter 11 of Title 11 of the United States Code, §§ 101 et seq. (as amended, the “Bankruptcy Code”). The Debtors continue to operate their businesses and manage their properties as debtors-in-possession pursuant to Sections 1107 and 1108 of the Bankruptcy Code. No trustee or examiner has been appointed in these cases.

2. On January 4, 2002, the United States Trustee for the District of Delaware held an organizational meeting and appointed the Premiere Committee to represent the interests of the

unsecured creditors of Premiere Associates, Inc. and its direct and indirect Subsidiaries. The members of the Premiere Committee are: (i) Angell Care, Inc. and Bermuda Village Limited Partnership, Attn: Don G. Angell; (ii) Healthcare Services Group, Inc.; and (iii) Great Oaks Nursing Home, Inc.

RELIEF REQUESTED

3. The Premiere Committee seeks final approval of all Premiere Committee member expenses applied for in all interim applications. The Premiere Committee has previously submitted interim applications for reimbursement of expenses as follows:

- a. for the period from January 4, 2002 through May 31, 2002 in the amount of \$13,731.51; and
- b. for September 13, 2002 in the amount of \$2,218.45.

4. The Court has previously approved all interim applications submitted by the Premiere Committee.

5. The Premiere Committee requests final approval of all interim applications filed by the Premiere Committee in these cases, in the total amount of \$15,949.96 for reimbursement for actual and necessary expenses incurred.

6. A summary of the out-of-pocket expenses incurred by the Premiere Committee for the Final Period is attached hereto as Exhibit A. The previously filed interim applications included detailed descriptions of the expenses and copies of their respective receipts.

7. The expenses that are the subject of the Final Application were actual and necessary expenses incurred by the Premiere Committee in the discharge of its duties in the Premiere Debtors' cases.

8. Notice of this Final Application has been sent to the Office of the United States Trustee and all parties in interest that have requested notice pursuant to Rule 2002 of the Federal Rules of Bankruptcy Procedure. In light of the relief requested herein, the Premiere Committee submits that no further notice of the Final Application is necessary.

WHEREFORE, the Premiere Committee respectfully requests final approval of all Premiere Committee member expenses in these cases, in the total amount of \$15,949.96 for actual and necessary costs and expenses incurred during the Final Period.
