Upon review and consideration of MSJR's Final Application
For Allowance of Fees and Expenses (May 29, 1996 to April 7, 1999)
for the unsealed time (the "Final Unsealed Application"), the
Declaration of J. Craig Gilliland in Support of the Final Unsealed
Application, the Declaration of George Basinger in Support of the
Final Unsealed Application, the arguments of counsel, and the record
in this case, the Court hereby finds that:

(i) notice of the Final Unsealed Application and the hearing on the Final Unsealed Application was provided to all entities who properly filed and served a request for special notice pursuant to this Court's "Order Limiting Notice, Establishing Notice Procedures, And Approving Form Of Notice Of § 341(a) Meeting Of Creditors;" and such notice fully and adequately described the relief requested in the Application and was reasonable and appropriate under the circumstances; and (ii) the payment and allowance on a final basis of the fees and expenses of MSJR, in the amounts set forth below, is reasonable and appropriate under the circumstances.

NOW, THEREFORE, IT HEREBY IS ORDERED THAT:

1. MSJR's fees in the amount of \$144,330.90 in unsealed fees and \$130,402.41 in expenses, for a total of \$274,733.31, incurred during the period from October 1, 1998 through April 7,

1999, are allowed as an expense of administration in KWI's Chapter 11 case;

- 2. KWI is authorized and directed to pay MSJR \$28,836.18, (the 20% holdback balance due from the period of October 1, 1998 through April 7, 1999 for unsealed fees);
- 3. KWI is authorized and directed to pay MSJR \$6,500.00 for the estimated fees for preparing the final applications (unsealed and sealed); and
- 4. MSJR's final application for the period of May 29, 1996 to April 7, 1999, in the final amount of \$1,750,388.35, (in total unsealed fees), plus \$371,403.32 (in total expenses), which application includes the amounts allowed under Paragraphs 1, 2, and 3 of this Order is finally allowed as an expense of administration in KWI's Chapter 11 Case under 11 U.S.C. Section 330(a) and 503(b) (2).
