## SUMMARIZE THE SERVICES RENDERED IN NARRATIVE FORM:

Services provided during the Subject Period included essential due diligence services on behalf of the Committee. The Committee had retained the Applicant to provide an objective review of the Debtors' books and records to determine the accuracy and reasonableness of recorded assets and liabilities, to ascertain whether the Debtors were viable, as well as to evaluate the integrity of the Debtors' accounting procedures and internal controls (i.e. safeguarding of assets). As unsecured creditors, the Applicant's constituents were not historically provided with financial information, and as such, did not have an understanding of the financial position and operating results of the Debtors. The Applicant's procedures were necessary in order to educate the Committee and provide valuable information in connection with the Debtors' operating losses and estimated recoveries, which may become available in the event of a liquidation. The Applicant continued to monitor the progress of the Debtor throughout the pendency of the bankruptcy in order to provide the Committee with valuable and timely data necessary to make informed decisions.

One component of Applicant's retention included meetings with management and a review of historical and recent financial information to gain an understanding of the Debtors' corporate and related party organization, historical operating results and financial condition, and anticipated operating results for the post-petition period. This analysis included a review of annual audited financial statements, internal monthly operating reports, internal operating and cash flow budgets, and the Debtors' cash and accrual basis business plans (the "Plans"). The Debtors' Plans represented management's analysis of the cost savings and revenue enhancements, which require implementation in order to stabilize the Debtors' operating and cash flow losses. The results of Applicant's analysis were included in a memorandum to the Committee and Counsel. Applicant's investigation of the Debtors' corporate organization. The knowledge and information gained from this component of J.H. Cohn's retention served as the foundation for subsequent services. It also provided the Applicant with an overview of the Debtors' current operating and financial environment, which was communicated to the Committee in a timely fashion.

Another component of Applicant's retention was a detailed investigation and analysis of the Debtors' recorded and unrecorded assets and liabilities. This analysis was requested by the Committee and was required to verify the existence and realization values of the Debtors' accounts receivable, property and equipment and other assets. In the independent ongoing evaluation of the Debtor's monthly reporting of the realization of accounts receivable, included an analysis by customer age, transaction type (swaps), and financial category (bankrupt entities) which was necessary to fully understand the reasonableness and sufficiency of recorded reserves for bad debts. Additionally, the investigation of the Debtors' liabilities focused on the amounts due to/from the related entities and the Debtor/non-debtor subsidiariesas well as understanding and monitoring the post petition liabilities reported on a monthly basis.

The Applicant's procedures included weekly reporting to the Committee, wherein actual cash flow results were analyzed to determine their compliance with the budget. In addition, the Applicant

analyzed and reported as to the propriety of the variances. Applicant also investigated the effect of any variances on future cash flows of the Debtors. Applicant also analyzed the reasonableness of the Debtor's proposed weekly cash flow projections for the period extending through June 2003. An analysis of this information was required to determine whether the Debtor would have sufficient liquidity in order to sustain operations through the projection periods. The Applicant circulated weekly flash reports to the Committee, which included highlights of the Debtors' liquidity and results of operations.

In July 2002, management set forth its Business Plan for the three years ending June 30, 2005. This Business Plan was revised in August 2002 and revised again in November 2002 and redistributed. Following that, the Debtor issued Business Plans in March 2003 and June 2003, which would form the basis for the Debtor's Plan of Reorganization. The Committee and Counsel requested that the Applicant perform an analysis of the Plan to validate the viability of the Debtors' remaining operations and to determine the feasibility of management's projections. The Applicant's review included extensive meetings with management (and other personnel designated by Management) to discuss approach, methodology and assumptions utilized. In addition, budgeted operating results were compared to historical results and normalized results. The results of our analysis was communicated to the Committee and Counsel in both written and oral formats that assisted the Committee in understanding the Debtor's Plan of Reorganization.

The Applicant participated in meetings with the Committee in discussions with Management during the development of the Debtor's Disclosure Statement and Plan of Reorganization documents. The Applicant assisted the Committee and Counsel in determining that the Debtor's plan adhered to the Committee's intercreditor agreement as well as certain other conditions to confirmation.

The Applicant also participated in the complex analysis of claims by class and the calculation of shares and rights relating thereto, which included providing creditors information necessary in understanding the plan of reorganization.

Further, Counsel to the Committee requested that Applicant evaluate the financial ramifications of numerous motions that had been filed by the Debtors. These motions included the assumption and/or rejection of certain lease agreements, payment of retention bonuses and severance to key management personnel, sale of miscellaneous assets, sale of real estate and business units and the Debtors use of cash collateral. Additionally, the Applicant was requested to work with special litigation counsel reviewing financial records and preparing analyses, as well as participating with Counsel in meetings and teleconferences.

## FOURTH AND FINAL APPLICATION FOR ALLOWANCE OF COMPENSATION AND REIMBURSEMENT OF EXPENSES BY J.H. COHN LLP AS ACCOUNTANTS AND FINANCIAL ADVISORS TO THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS FOR THE PERIOD JULY 1, 2003 THROUGH SEPTEMBER 7, 2003

# TO THE HONORABLE ADLAI S. HARDIN, JR. UNITED STATES BANKRUPTCY JUDGE:

This Fourth and Final application for allowance of compensation of \$272,002.50 and

reimbursement of expenses of \$6,386.26 by J.H. Cohn LLP, as accountants and financial

advisors to the Official Committee of Unsecured Creditors (the "Committee") for the period July

1, 2003 through September 7, 2003, is submitted pursuant to Sections 330 and 331 of the

Bankruptcy Code (the "Code"), 11 U.S.C. §101, et seq., Federal Rules of Bankruptcy Procedure

2016(a), the April 19, 1995 Guidelines for Fees and Disbursements for Professionals for

Southern District of New York Bankruptcy cases, and the Revised Guidelines dated January 30, 1996 for Reviewing Applications for Compensation and Reimbursement of Expenses filed under 11 U.S.C. § 330, issued by the United States Trustee (the "Revised Guidelines"). Applicant respectfully represents as follows:

1. J.H. Cohn LLP ("J.H. Cohn") is a firm of accountants and consultants retained by the Committee as its financial advisors.

2. J.H. Cohn's retention was approved by this Court by Order dated July 18, 2002, *nunc pro tunc* to June 3, 2002. A copy of the Order (the "Retention Order") is annexed hereto as Exhibit "A."

3. The Retention Order provides that all compensation and reimbursement of costs and expenses incurred during applicant's employment be made only after appropriate application and approval of this Court.

4. This application seeks allowance of compensation for professional services rendered to the Committee for the time period July 1, 2003 through September 7, 2003 (the "Subject Period"), for which J.H. Cohn has not previously sought interim compensation. This application also seeks final approval of all fees and expenses for the period October 1, 2002 through September 7, 2003, including "holdback" fees for the prior application period.

5. To the extent this Final Application seeks allowance of compensation for the time period covered by J.H. Cohn's First through Third applications, those applications are incorporated by reference in this Final Application. Attached hereto as Exhibit "C" is a complete history of fees and expenses from inception through September 7, 2003, including prior applications, interim billings, payments and holdbacks.

This application is submitted pursuant to the provisions of the Order Pursuant to
 11 U.S.C. §§ 105(a) and 331 Establishing Procedures for Monthly Compensation and
 Reimbursement of Expenses of Professionals (the "Interim Compensation Order") dated June 5,
 2002.

7. Applicant values the services rendered during the Subject Period to the Committee at \$272,002.50. Such amount represents the Applicant's usual and customary charges for services of a similar nature performed for other clients of the firm and computes to an average hourly rate of \$297.09. A summary indicating all professionals who rendered services to the Committee, their hourly billing rates, the amount of time spent by each individual, the total dollar value of each person's time and the overall average hourly rate charged during the Subject Period is attached hereto as Exhibit "B1".

8. Pursuant to the provisions of the Interim Compensation Order, Applicant has submitted monthly interim billings and has received interim payments representing 80% of fees and 100% of disbursements. A complete schedule of interim billings and payments received is annexed hereto as Exhibit "C".

9. The following is a summary of services provided by J.H. Cohn at the direction of the Committee and/or its counsel:

- (a) To determine Debtors' short-term cashflow requirements and availability of assets to support use of cash collateral;
- (b) To gain an understanding of Debtors' accounting systems;
- (c) To monitor Debtors' post-petition operating results and cash flows;
- (d) To ascertain Debtors' current financial condition;
- (e) To review historical financial information;

- (f) To review key employee retention plans;
- (g) To review proposed financing commitments;
- (h) To review Debtors' expense structure and identify opportunities for further reductions;
- (i) To prepare a liquidation analysis;
- (j) To analyze Debtors' business plan;
- (k) To identify and/or evaluate strategies to maximize the value of the estate, including the sale of non-strategic assets;
- To review the books and records of Debtors for related party and/or potential avoidance actions;
- (m) To ascertain the reasonableness of Debtors' long-term viability and plan of reorganization;
- (n) To render other bankruptcy and consulting services, attend hearings and/or meetings, and render such assistance as the Creditors' Committee and its counsel may deem necessary.

10. Annexed hereto as Exhibit "D" is a detailed description of the professional services rendered by J.H. Cohn during the Subject Period, including the date the service was performed, the identity of the individuals rendering such services, the hours expended by them and a description of the services performed. The charges associated with such services during the Subject Period based upon J.H. Cohn's standard hourly rates amounted to \$272,002.50.

11. J.H. Cohn also incurred necessary out-of-pocket expenses in the sum of \$6,386.26 during the Subject Period related to the aforesaid services, which are summarized on Exhibit

"B1" attached hereto. A detailed breakdown of travel expenses is annexed hereto as Exhibit "B2."

WHEREFORE, J.H. Cohn LLP respectfully requests that this Court approve its Fourth and Final Application For Compensation as Accountants and Financial Advisors to the Official Committee of Unsecured Creditors of Metromedia Fiber Network, Inc., as follows:

- (i) For allowance of compensation for professional fees in the amount of\$272,002.50 for the period July 1, 2003 through September 7, 2003;
- (ii) For reimbursement of necessary out-of-pocket expenses in the amount of\$6,386.26 for the period July 1, 2003 through September 7, 2003;
- (iii) For a total interim allowance of \$278,388.76; and,
- (iv) For Final approval of fees and expenses from inception through September 7, 2003 of \$2,424,553.50 and \$82,984.69, respectively, including "holdback" fees in the amount of \$182,520.18 as more fully set forth on Exhibit "C";
- (v) For a final payment of unpaid fees totaling \$346,496.98.
