ORDER APPROVING FINAL FEE APPLICATION REQUEST

Upon the Final Fee Application Request (the "Request") of the professional referenced on Exhibit A attached hereto (the "Applicant"), pursuant to Article III, Section B.3.c of that certain Second Amended Joint Plan of Reorganization of Debtors and Debtors in Possession, the confirmation order for which was entered on November 17, 2004, for final allowance of certain fees, including, but not limited to, all holdbacks, and expenses, for the period from February 23, 2004 through January 31, 2005 (the "Final Compensation Period"), filed pursuant to the Administrative Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses of Professionals dated March 22, 2004 [Docket No. 225] (the "Administrative Order") and the Order Appointing Fee Auditor and Establishing Related Procedures Concerning the Allowance and Payment of Compensation and Reimbursement of Expenses of Professionals and Members of Official Committees and Consideration of Fee Applications dated May 27, 2004 [Docket No. 944] (the "Fee Auditor Order"); and the Court having reviewed the application of the Applicant for allowance of interim compensation for professional services and for reimbursement of expenses referenced on Exhibit A attached hereto (the "Application"); and the Court having reviewed the Request; and the Court finding that: (a) the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; (b) notice of

the Request and the Application, and any hearing thereon, was adequate under the circumstances; and (c) all persons with standing have been afforded the opportunity to be heard on the Request and the Application, it is hereby

ORDERED that the Request is granted, as modified herein; and it is further

ORDERED that the Applicant is allowed compensation for services rendered during the Final Compensation Period, and is allowed reimbursement for actual and necessary expenses incurred during the Final Compensation Period in the amounts set forth on Exhibit A hereto, including any and all holdbacks; and it is further

ORDERED that the Applicant will refund any balance, in excess of the amounts set forth herein and any amounts payable for the period since the end of such Final Compensation Period not to exceed \$4,000.00, due to the Debtors within ten days after the entry of this order.
