persons with standing have been afforded the opportunity to be heard on the Application; and (e)

allowance on a final basis of the fees and expenses of Cooley, in the amounts set forth below, is reasonable and appropriate under the circumstances.

## NOW THEREFORE, IT IS HEREBY ORDERED THAT:

- 1. The Application is GRANTED;
- 2. Cooley's fees in the amount of \$756,296.25 and expenses in the amount of \$31,844.59 incurred during the period from December 1, 2003 through April 12, 2004 are allowed as an expense of administration in this Chapter 11 case;
- Such sums are authorized for payment less the amounts previously paid to Cooley 3. pursuant to the monthly fee application procedure approved by the Court, i.e. \$674,696,47 in fees and costs, leaving a sum of \$113,444.37 due and owing, which the PG&E is now authorized and directed to pay to Cooley;
- 4. The fees and expenses awarded to Cooley in its prior eight Interim Applications and in the instant Ninth and Final Period, in the aggregate amount of \$13,182,342.50 in fees and \$1,017,163.27 in expenses, are hereby deemed final compensation and not subject to further review or objection; and
- 5. This is a final order and constitutes a final determination regarding the allowance of all of Cooley's fees and expenses.
