
25 ORDERED, that W&S shall be allowed final compensation in the amount of

1 ORDERED, that W&S shall be allowed final compensation in the amount of
2 \$3,625,670.26 and reimbursement of expenses in the amount of \$269,159.69 for a total of
3 \$3,894,829.95 for the period of August 16, 2001 through April 12, 2004; and it is further

4 ORDERED, that the Debtor is directed to immediately pay the allowed amount
5 less any amounts already paid pursuant to the Fee Order.
