
1 The Ninth Interim and Final Application for Approval of Payment of Compensation and  
2 Reimbursement of Expenses by Kecker & Van Nest, L.L.P. to Debtor in Possession came on

5 The Court having considered the Ninth Interim and Final Application and the Court

15 (consisting of \$1,752,099.47 for services rendered and \$126,431.50 for reimbursement of  
16 expenses) for the period of April 1, 2001 through and including April 12, 2004;
- 17 4. PG&E is authorized to pay to Kecker & Van Nest, L.L.P. the unpaid portion of the  
18 foregoing approved compensation.
