1 ("Application") came before the Court for hearing at the above-stated date and time.

2 Appearances were as noted on the record.

3 Notice of hearing having been provided as set forth in the papers on file with the
4 Court, the Court having carefully reviewed the Application, no objections having been received
5 to the Application, the amounts requested being for reasonable compensation for actual,
6 necessary services rendered by Doney, Crowley, Bloomquist & UDA, P.C. ("Doney, Crowley")
7 and reimbursement for actual, necessary expenses within the meaning of 11 U.S.C. §330(a), and
8 good cause appearing for approval thereof;

9 **IT IS ORDERED** that the Application shall be and hereby is approved and Doney,
10 Crowley shall be and hereby is entitled to interim compensation and reimbursement of expenses
11 for the period December 1, 1998 through February 5, 1999 in the amount of \$8563.69.

12 **IT IS FURTHER ORDERED** that Liquidating Trustee Harrison J. Goldin, on behalf
13 of the Pegasus Gold Corporation Liquidating Trust, shall be and hereby is authorized and
14 directed to pay to Doney, Crowley \$8563.69 of which \$8,410.00 represents compensation for
15 professional services rendered and \$153.69 represents reimbursement for expenses incurred and
16 which constitutes the sum of all unpaid fees and expenses awarded by this Court for this interim
17 application period and prior application periods.

18 **IT IS FINALLY ORDERED** that Doney, Crowley shall be and hereby is finally
19 allowed the fees and expenses awarded to it for services rendered and expenses incurred from
20 August 19, 1998 through February 5, 1999, including the interim compensation and
21 reimbursement allowed by this Order.
