ORDER APPROVING FOURTH INTERIM AND FINAL FEE APPLICATION OF GOUGH, SHANAHAN, JOHNSON & WATERMAN SEEKING COMPENSATION FOR LEGAL SERVICES RENDERED AND REIMBURSEMENT OF EXPENSES

16 This matter having come before the Court on May 17, 1999, for hearing on the *Fourth*
 17 *Interim and Final Fee Application of Gough, Shanahan, Johnson & Waterman Seeking*
 18 *Compensation for Legal Services Rendered and Reimbursement of Expenses* (the
 19 “Application”) filed by the law firm of Gough, Shanahan, Johnson & Waterman (“GSJW”);
 20 William P. Driscoll appearing on behalf of GSJW and other appearances as duly noted on the
 21 record; the Court having reviewed the Fourth Interim and Final Fee Application of Gough,
 22 Shanahan, Johnson & Waterman, the Court having heard the oral arguments of counsel, and
 23 good cause appearing therefor;

24 **IT IS HEREBY ORDERED** pursuant to Bankruptcy Code §§ 330 and 331 the
 25 Application is approved in the amounts set forth below; that the total amount of professional

1 fees charged by GSJW to the Debtors during their Chapter 11 cases are reasonable within the
2 meaning of 11 U.S.C. § 330(a); that the total amount of reimbursable expenses incurred by
3 GSJW during the Chapter 11 cases were actual and necessary within the meaning of 11 U.S.C.
4 § 330(a); and that final approval is given to all fees and costs previously awarded by interim
5 orders.

6 **IT IS FURTHER ORDERED** that the Debtors are authorized and directed to
7 immediately pay GSJW's request for **compensation incurred** during this Application Period in
8 the sum of **\$19,808.38 reimbursement expenses in the sum of \$639.08 for a total of**
9 **\$20,447.46.**
