PLEASE TAKE NOTICE that on August 24, 2006, Sidley Austin LLP (“Sidley”) filed the **Sixth Monthly and Final Application for Allowance of Compensation and Reimbursement of Expenses of Sidley Austin LLP For Services Rendered and Expenses Incurred as Counsel To The Debtors Pursuant to 11 U.S.C. §§ 105 and 331** [Docket No. 1093] (the “Final Fee Application”). The Final Fee Application sought final fees in the amount of \$6,479,973.00 and final expenses in the amount of \$297,121.73².

PLEASE TAKE FURTHER NOTICE that since the filing of the Final Fee Application, Sidley has received additional invoices due to a lag between invoicing and receipt from certain vendors totaling \$61,085.77 of additional expenses incurred prior to the Effective


