FIRST AND FINAL APPLICATION OF LATHAM & WATKINS LLP FOR ALLOWANCE AND PAYMENT OF COMPENSATION AND REIMBURSEMENT OF EXPENSES AS SPECIAL INVESTIGATION COUNSEL TO THE AUDIT COMMITTEE OF THE DEBTORS' BOARD OF DIRECTORS

Pursuant to sections 330 and 503(b)(1)(A) of chapter 11 of Title 11 of the United States Code (the "Bankruptcy Code"), Rule 2016 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), the Amended Guidelines for Fees and Disbursements for Professionals in Southern District of New York Bankruptcy Cases adopted by the Court on April 19, 1995 (the "Local Guidelines") and the United States Trustee Guidelines for Reviewing Applications for Compensation and Reimbursement of Expenses Filed Under 11 U.S.C. § 330, adopted on January 30, 1996 (the "UST Guidelines" collectively with the Local Guidelines, the "Guidelines"), Latham & Watkins LLP ("Latham"), special investigation counsel to the Audit Committee of the Board of Directors of the above-captioned debtors and debtors-in-possession (the "Debtors"), respectfully submits this first and final application (the "Application") for allowance of compensation totaling \$285,980.50, and reimbursement of expenses totaling

In addition to Refco Inc., the following entities are debtors in these related cases: Bersec International LLC, Kroeck & Associates, LLC, Marshall Metals LLC, New Refco Group Ltd., LLC, Refco Administration LLC, Refco Capital LLC, Refco Capital Holdings LLC, Refco Capital Management LLC, Refco Capital Markets, Ltd., Refco Capital Trading LLC, Refco Finance Inc., Refco Financial LLC, Refco Fixed Assets Management LLC, Refco F/X Associates LLC, Refco Global Capital Management LLC, Refco Global Finance Ltd., Refco Global Futures LLC, Refco Global Holdings LLC, Refco Group Ltd., LLC, Refco Information Services LLC, Refco Mortgage Securities, LLC, Refco Regulated Companies LLC, and Summit Management LLC.

\$15,660.77, incurred during the period from October 18, 2005 through January 31, 2006 (the "Compensation Period").

In support of this Application, Latham respectfully represents as follows:

Background

- 1. On October 17, 2005 (the "Petition Date"), the Debtors filed voluntary petitions for relief under chapter 11 of the Bankruptcy Code. The Debtors are managing their properties as debtors in possession under Bankruptcy Code sections 1107(a) and 1108.
- 2. On December 16, 2005, the Debtors filed that certain Application for Authority to Retain Latham & Watkins LLP as Special Investigation Counsel to the Audit Committee of the Debtors' Board of Directors and for Approval of the Application of Retainer and Interim Payment of Fees (the "Retention Application"). On December 23, 2005, this Court entered an interim order (the "Interim Order") approving the retention of Latham, *nunc pro tunc* to the Petition Date. A final order authorizing the retention of Latham has been submitted to the Court, but has not yet been entered.
- 3. As set forth in the Retention Application, prior to the Petition Date, Latham received a retainer (the "Retainer"), in the amount of \$500,000.00, which remained unapplied as of the Petition Date.²

This Court's Interim Order authorized (i) the retention of Latham as special investigation counsel, (ii) the application of Latham's Retainer to pre-petition fees and expenses, which were represented in the Retention Application as totaling \$458,232.82, and (iii) the application of the balance of the Retainer to post-petition fees and expenses pursuant to a later-filed Fee Application. (As set forth in the First Supplemental Declaration of David M. Brodsky in Support of Debtors' Retention of Latham & Watkins LLP As Special Investigation Counsel to the Audit Committee of the Debtors' Board of Directors (the "First Supplemental Declaration"), the Interim Order appears to contain a typographical error and incorrectly lists \$49,000 as the amount represented as the value of legal services rendered by Latham pre-petition.) The First Supplemental Declaration further noted that the Retention Application understated the pre-petition expenses by \$9,456.31. Thus, the actual pre-petition fees and expenses to which the Retainer is to be applied total \$467,689.13. Latham continues to hold \$41,767.18 for partial satisfaction of post-petition fees and expenses.

- 4. By Order dated December 13, 2005 (the "Administrative Order"), the Court established a procedure for interim compensation and reimbursement of expenses for all professionals in these cases. In particular, the Administrative Order provides that, absent objection, upon the expiration of twenty days after the service of any monthly fee statements, the Debtors are authorized to pay each professional an amount equal to 80 percent of the fees and 100 percent of the expenses requested in their respective monthly fee statements. Because of the timing of Latham's retention in this case, Latham did not serve any monthly fee statements, and instead files only this first and final Application.
- 5. By this Application, Latham seeks final allowance of all fees and expenses incurred during the Compensation Period. Latham also seeks final authority to apply the balance of its Retainer, totaling \$41,767.18, in partial satisfaction of the outstanding pre-petition fees and expenses, and fees and expenses requested herein. Finally, Latham seeks payment from the Debtors of all remaining outstanding fees and expenses after application of its Retainer to the aforementioned fees and expenses.
- 6. The supervisory responsibility for Latham's efforts on behalf of the Debtors was undertaken by David M. Brodsky, a partner in Latham's New York office. Mr. Brodsky is a 1964 graduate of Brown University and a 1967 graduate of the Harvard University Law School.

Summary of Services Performed During the Compensation Period

7. As is reflected in the attached First and Final Fee and Expense Application Cover Sheet of Latham & Watkins LLP as Special Investigation Counsel to the Audit Committee of the Debtors' Board of Directors (the "Cover Sheet"), Latham has rendered 596.70 hours of legal services in representation of the Debtors from October 18, 2005 through January 31, 2006.

Based upon the nature of the services rendered, the time required to provide such services, the

value of such services to the Debtors, and the cost of comparable services outside a case under the Bankruptcy Code, Latham believes that the compensation for services rendered to the Debtors, should be not less than \$285,980.50. This total represents 596.70 hours of Latham attorney and other professional time, at a blended average hourly rate of \$479.27. The hourly rate for each attorney and other professional who performed services for the Debtors is set forth in the Cover Sheet.

- 8. All of the fees and expenses requested in this first and final Application are for legal services that Latham rendered on behalf of the Audit Committee. Latham did not render legal services to Refco Capital Markets, Ltd. ("RCM"). As a result, Latham has no separate time records, fees or expenses associated with services rendered on behalf of RCM.
- 9. In accordance with the Local Guidelines, a detailed chronological narrative (the "Billing Detail") of the time spent (divided among six (6) applicable billing categories), the dates and descriptions of the services rendered, and the identity of the attorneys and other professionals who provided services on behalf of the Debtors from October 18, 2005 through January 31, 2006, is attached hereto as Exhibit "A," and incorporated herein by reference. Section III of the Cover Sheet, contains a summary of the services provided by project category.
- 10. Latham respectfully supplements the attached Billing Detail with the following narrative summary of services rendered by Latham, organized by category.
- a) General Case Administration. Latham rendered a total of 120.10 hours and \$70,017.00 in services in the category "General Case Administration." This project contains all of Latham's services rendered in connection with the overall management of the case. Latham held conference calls with the Audit Committee, management, employees and staff of the Debtors. Latham also held office conferences by and between attorneys and staff of Latham and

FTI, the forensic accountants that assisted Latham with the investigation. This project also contains all of the services rendered in connection with maintaining files, monitoring case dockets to remain current on case status, and managing the information collected during the course of Latham's investigation.

- b) Investigation. Latham rendered a total of 248.80 hours and \$103,819.00 in services in the category "Investigation." This project contains all of Latham's services rendered in connection with the investigation of management, employees, records and data of the Debtors. Latham conducted extensive interviews and collected a substantial amount of information from management, employees, records and data of the Debtors. This project also includes the review and analysis of documents, records and other information collected in connection with the investigation.
- c) <u>Communications/Coordination with Debtors' Counsel.</u> Latham rendered a total of 22.20 hours and \$8,975.00 in services in the category "Communications/Coordination with Debtors' Counsel." This project contains all of Latham's services rendered in connection with providing information and analysis related to its investigation to Debtors' counsel. Latham cooperated with Debtors' counsel in order to comply with requests for information from various government agencies and regulatory bodies. This project also includes the transfer of information and records from Latham to Debtors' counsel.
- d) Responses to Regulators. Latham rendered a total of 34.90 hours and \$19,516.50 in services in the category "Responses to Regulators." This project contains all of Latham's services rendered in connection with responding to requests for documents and information from various government agencies and regulatory bodies, including the Securities and Exchange Commission, the United States Attorney for the Southern District of New York,

the Chicago Mercantile Exchange, the Commodity Futures Trading Commission, the National Association of Securities Dealers and the New York Stock Exchange (collectively, the "Regulators"). Latham participated in conference calls, meetings, and presentations and produced documents to the Regulators.

- e) Retention Issues. Latham rendered a total of 166.00 hours and \$81,230.50 in services in the category "Retention Issues." This project contains all of Latham's services rendered in connection with preparing and filing its retention application and supporting documents in this chapter 11 case, and in addressing certain objections raised in respect thereto. In submitting this first and final Application, Latham is voluntarily waiving its right to seek compensation for fees of approximately \$5,000.00 to which it believes it would otherwise be entitled for services related to Retention Issues rendered after the Compensation Period.
- f) **Fees Application.** Latham rendered a total of 4.70 hours and \$2,422.50 in services in the category "Fees Application." This project contains Latham's services in connection with preparing and filing its fee application during the Compensation Period. In submitting this first and final Application, Latham is voluntarily waiving its right to seek compensation for fees of approximately \$15,000.00 to which it believes it would otherwise be entitled for services related to preparation of this Application rendered after the Compensation Period.

<u>Latham's Staffing and Internal Procedures</u>.

10. Latham has made a conscious effort in this case to provide the Debtors with high quality legal services at the lowest possible cost. Latham respectfully submits that it has been extremely efficient in avoiding duplication of effort and keeping fees and costs at the lowest level possible.

11 Latham believes that the attached Billing Detail reflects the actual, fair and reasonable value of the legal expertise provided to the Debtors during the Compensation Period.

Disbursements

- 12. Latham expended a total of \$15,660.77 for reasonable and necessary expenses in connection with its representation of the Debtors from October 18, 2005 through January 31, 2006. In accordance with the Guidelines, Section IV of the Cover Sheet attached hereto and incorporated herein by reference, also contains a summary of the expenses incurred by type.
- 13. Latham does not build a profit component into its disbursements, and charges the Debtors only for Latham's actual out-of-pocket expenses. Photocopy charges are billed at \$0.17 per page.

Certification

14. As required by the Guidelines, a certification that the facts set forth in this Application are true and correct, and that this Application complies with the Guidelines, is attached hereto as Exhibit "B."

Latham is a Disinterested Person and Holds No Adverse Interest

Application were performed by Latham on behalf of the Audit Committee of the Debtors' Board of Directors and not on behalf of any other entity or person. Latham has neither a claim against, nor an interest in, the Debtors, and no beneficial interest in the Debtors, directly or indirectly, has been acquired or transferred by Latham or for Latham's benefit since the commencement of these cases. Latham represents no interest adverse to the Debtors with respect to matters upon which it is engaged, and Latham is a "disinterested person" under section 101(14) of the Bankruptcy Code.

16. No agreement or understanding exists between Latham and any other person or

entity for the sharing of compensation received or to be received for services rendered in

connection with these proceedings, except that fees will be shared with other partners of Latham

as permitted by Bankruptcy Rule 2016 and Section 504 of the Bankruptcy Code.

WHEREFORE, Latham respectfully requests that this Court enter an order allowing on a

final basis (i) compensation in the sum of \$285,980.50 for actual, reasonable and necessary

professional services rendered on behalf of the Debtors during the Compensation Period,

including application of the remainder of the Retainer totaling approximately \$41,767.18 in

partial satisfaction of such fees and (ii) reimbursement in the amount of \$15,660.77 for actual,

reasonable and necessary expenses incurred during the Compensation Period. Latham further

requests that this Court's order approving this Application: (i) direct the Debtors to pay Latham

the full amount of these fees to the extent not already paid, and (ii) direct the Debtors to

reimburse Latham in the amount of \$15,660.77 for actual, reasonable and necessary expenses

incurred during the Compensation Period.
