**ORDER GRANTING FIRST AND FINAL APPLICATION
OF COMMITTEE MEMBERS' FOR FINAL ALLOWANCE OF
REIMBURSEMENT OF ACTUAL AND NECESSARY EXPENSES
INCURRED FROM MAY 8, 2006 THROUGH SEPTEMBER 19, 2006**

Upon the hearing held on March 1, 2007 (the "Hearing") to consider the application (the "Application") for final allowance of reimbursement of actual and necessary expenses incurred pursuant to sections 330(a) and 331 of title 11 of the United States Code (the "Bankruptcy Code") and Rule 2016 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), filed by certain members of the official committee of unsecured creditors listed on Exhibit A annexed hereto (the "Committee Members") in the above-captioned chapter 11 cases of Silicon Graphics, Inc. and certain of its direct and indirect subsidiaries, as debtors and debtors in possession in the above-captioned chapter 11 cases (collectively, the "Debtors" and as reorganized, the "Reorganized Debtors"); and the Court having considered the Amended Guidelines for Fees and Disbursements for Professionals in Southern District of New York Bankruptcy Cases adopted by the Court on April 19, 1995, the United States Trustee Guidelines for Reviewing Applications for Compensation and Reimbursement of Expenses Filed Under 11

U.S.C. § 330, adopted on January 30, 1996, and the Order Pursuant to Sections 105(a) and 331 of the Bankruptcy Code and Bankruptcy Rule 2016(a) Establishing Procedures for Interim Monthly Compensation and Reimbursement of Expenses of Professionals, dated May 31, 2006 (the “Interim Compensation Order”); and upon the Statement and Objection to Final Fee Requests of Professionals, dated February 23, 2007 (the UST’s Statement”), filed by the Office of the United States Trustee and the brief in support filed on February 28, 2007; and upon the response to the UST’s Statement filed by counsel to the Reorganized Debtors; and the Court having jurisdiction to consider the Applications and the relief requested therein pursuant to 28 U.S.C. §§ 157 and 1334; and the Committee Members having submitted certifications of their holdings throughout the case to the Office of the United States Trustee; and the Office of the United States Trustee having consented to the payment of the expenses requested in the Application; and it appearing that due and proper notice of the Application has been given; and the Court having reviewed the Application; and the Court having determined that the relief requested in the Application is in the best interests of the Debtors, their estates and their creditors; and upon all of the proceedings had before the Court; and for the reason stated by the Court on the record of the Hearing, it is hereby

ORDERED that the Application is granted in the amounts as set forth in Exhibit A annexed hereto; and it is further

ORDERED that reimbursement to the Committee Members for expenses incurred during the time period set forth in the Application is allowed on a final basis in the amounts set forth on Exhibit A in the column entitled “Expenses Allowed”; and it is further

ORDERED that the reimbursement of expenses set forth on Exhibit A shall be allocated as follows: (i) Solectron the sum of \$3,249.12; (ii) Pinnacle Data the sum of \$824.26; and (iii) Hammerman Capital the sum of \$344.84; and it is further

ORDERED that the Debtors are authorized to make payment to the Professionals in satisfaction of all such allowed expenses that have not previously been paid pursuant to the Interim Compensation Order or otherwise.
