FIRST AND FINAL APPLICATION OF KPMG LLP, AS ACCOUNTANTS AND AUDITORS TO DEBTORS, FOR ALLOWANCE OF COMPENSATION FOR PROFESSIONAL SERVICES RENDERED AND REIMBURSEMENT OF ACTUAL AND NECESSARY EXPENSES INCURRED FROM JUNE 19, 2006 THROUGH SEPTEMBER 19, 2006

TO THE HONORABLE BURTON R. LIFLAND UNITED STATES BANKRUPTCY JUDGE:

KPMG LLP ("KPMG"), a professional services firm, accountants and auditors to Silicon Graphics, Inc., and its direct and indirect subsidiaries in the above-referenced chapter 11 cases, as debtors and debtors-in-possession (collectively, the "Debtors"), submit its first and final application (the "Application"), pursuant to sections 330(a) and 331 of title 11 of the United States Code (the "Bankruptcy Code") and rule 2016 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), for the allowance of

compensation for professional services performed by KPMG for the period commencing June 19, 2006 through and including September 19, 2006 (the "Compensation Period"), and for reimbursement of its actual and necessary expenses incurred during the Compensation Period, and respectfully represents:

Background

- 1. On May 8, 2006 (the "Commencement Date"), the Debtors each commenced with this Court a voluntary case under chapter 11 of the Bankruptcy Code. The Debtors are authorized to continue to operate their businesses and manage their properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code.
- 2. The Debtors' chapter 11 cases have been consolidated for procedural purposes only and are being jointly administered pursuant to rule 1015(b) of the Bankruptcy Rules. On May 19, 2006 the United States Trustee for the Southern District of New York (the "US Trustee") appointed an official committee of unsecured creditors (the "Creditors' Committee").
- 3. On June 30, 2006, the Debtors filed their First Amended Joint Plan of Reorganization under Chapter 11 of the Bankruptcy Code (the "Plan") and the Disclosure Statement for the First Amended Joint Plan of Reorganization under Chapter 11 of the Bankruptcy Code (the "Disclosure Statement"). On July 27, 2006, the Court entered an order approving the Disclosure Statement. An Order was signed and the Plan was confirmed on September 19, 2006.

Jurisdiction

- 4. This Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334. Venue is proper pursuant to 28 U.S.C. §§ 1408 and 1409. This matter is a core proceeding under 28 U.S.C. § 157(b)(2).
- 5. The statutory predicate for the relief requested herein are sections 330 and 331 of the Bankruptcy Code and Bankruptcy Rule 2016.

KPMG LLP Retention

6. On August 10, 2006 the Debtors filed a retention application (the "Retention Application") pursuant to sections 327(a) and 328(a) and 1107(b) of the Bankruptcy code and Bankruptcy Rule 2014 for authorization to employ and retain KPMG as their accountants and auditors *nunc pro tunc* to June 19, 2006. On August 18, 2006, the Debtors filed a Supplement to the Retention Application (the "Supplement") pursuant to the terms of the revised engagement letter as described and defined therein (the "Engagement Letter"). On September 6, 2006, the Court entered an order approving the Retention Application, effective *nunc pro tunc* to June 19, 2006 (the "KPMG Retention Order").

Requested Fees and Reimbursement of Expenses

7. This Final Application has been prepared in accordance with (i) the Amended Guidelines for Fees and Disbursements for Professionals in Southern District of New York Bankruptcy Cases, adopted by the Court on April 19, 1995 (the "Local Guidelines"), (ii) the United States Trustee Guidelines for Reviewing Applications for Compensation and Reimbursement of Expenses Filed Under 11 U.S.C. § 330, adopted on January 30, 1996 (the "UST Guidelines") and (iii) the Order Under 11 U.S.C. § 331

Establishing Procedures for Monthly Compensation and Reimbursement of Expenses of Professionals (The "Administrative Order", and collectively with Local Guidelines, the "Guidelines), dated April 30, 2003. Pursuant to the Local Guidelines, a certification regarding compliance is attached hereto as Exhibit "A".

8. By this Final Application, KPMG respectfully requests an allowance for professional services rendered to the Debtors during the Compensation Period, in the aggregate of \$4,387,500.68 and for reimbursement of expenses incurred in connection with the rendering of such services in the aggregate of \$58,868.71. During the Compensation Period, KPMG professionals and paraprofessionals expended a total of 14,757.5 hours for which compensation is requested. KPMG's request for compensation is broken down as follows:

9. KPMG charges its fees in these cases in accordance with billing rates and procedures in effect during the Compensation Period. The rates KPMG charges for the services rendered by its professionals and paraprofessionals in these chapter 11 cases are the same rates KPMG charges for professional and paraprofessional services rendered in comparable nonbankruptcy related matters. Such fees are reasonable based on the

customary compensation charged by comparably skilled practitioners in comparable nonbankruptcy cases.

- 10. Pursuant to the UST Guidelines, annexed as Exhibit "B" is a schedule setting forth all KPMG professionals and paraprofessionals who have performed services in these chapter 11 cases during the Compensation Period, the capacities in which each such individual is employed by KPMG, the hourly billing rate charged by KPMG for services performed by such individual, aggregate number of hours expended in this matter and fees billed therefor.
- 11. Annexed as Exhibit "C" is a schedule specifying the categories of expenses for which KPMG is seeking reimbursement and the total amount for each such expense category.
- 12. Pursuant to Section II.D of the UST Guidelines, annexed as Exhibit "D" is a summary of KPMG's time records billed during the Compensation Period, including the utilization of project categories as described below.
- 13. To the extent that time or disbursement charges for services rendered or disbursements incurred relate to the Compensation Period, but were not processed prior to the preparation of this Final Application, KPMG reserves the right to request additional compensation for such services and reimbursement of such expenses in a future application.

Summary of Services

- 14. In accordance with the Engagement Letter, KPMG has provided such services as KPMG and the Debtors deemed appropriate and feasible in order to advise the Debtors and their subsidiaries and affiliates in the course of these chapter 11 cases, including, but not limited to, Integrated Audit Services.
- 15. The services provided by KPMG to the Debtors are not unnecessarily duplicative of those provided by any other of the Debtors' professionals, and KPMG has coordinated any services performed at the Debtors' request with the Debtors' other professionals, including financial advisors, accountants, and counsel, as appropriate, to avoid duplication of efforts.
- 16. Pursuant to Rule 2016(d)(3) of the Bankruptcy Local Rules, fee applications must include a detailed description of each major task performed by the applicant. Accordingly, the following is a summary of certain of the significant professional services rendered by KPMG during the Compensation Period, as well as the compensation sought for such services.

Description Of Task Codes

17. The following is a more detailed description of the significant professional services rendered by KPMG during the Compensation Period.

(a) Integrated Audit Services

- i. Auditing the Debtors' consolidated financial statements;
- ii. Auditing the Debtors' control over financial reporting;
- iii. Issuing an audit report;
- iv. Reviewing quarterly financial statements required to be filed with the Securities and Exchange Commission;
- v. Analyzing accounting issues and advising the Debtors regarding the proper accounting treatment of events; and
- vi. Performing other accounting and auditing services for the Debtors as may be necessary or desirable, to the extent permitted under professional standards and as agreed to between the Debtors and KPMG.

(b) Fee Statements and Fee Applications

Preparation of monthly fee statements and fee application.

- 18. The foregoing professional services performed by KPMG were necessary and appropriate to the administration of the Debtors' chapter 11 cases. The professional services performed by KPMG were in the best interests of the Debtors and other parties-in-interest. Compensation for the foregoing services, as requested, is commensurate with the complexity, importance, and nature of the problems, issues, or tasks involved. The professional services were performed expediently and in an efficient manner.
- 19. The professional services performed by KPMG on behalf of the Debtors during the Compensation Period required an aggregate expenditure of 14,757.5 recorded

hours by KPMG's professionals. Of the aggregate time expended, 474.9 recorded hours were expended by partners of KPMG, 14,282.6 recorded hours were expended by managers and staff of KPMG.

20. During the Compensation Period, KPMG billed the Debtors for time expended by professionals based on hourly rates ranging from \$250.00 to \$780.00 per hour. Allowance of compensation in the amount requested would result in a blended hourly billing rate of approximately \$303.84 (based on 14,299.4 recorded hours for professionals at KPMG's billing rates in effect at the time of the performance of services). As noted above, annexed as Exhibit B is a schedule listing each KPMG professional and paraprofessional who performed services in these cases during the Compensation Period, the hourly rate charged by KPMG for services performed by each such individual and the aggregate number of hours and charges by each such individual.

Actual and Necessary Disbursements of KPMG LLP

21. As set forth in Exhibit "C", KPMG has disbursed \$58,868.71 as expenses incurred in providing professional services during the Compensation Period. The actual expenses incurred in providing professional services were absolutely necessary, reasonable, and justified to serve the needs of the Debtors, their estates, and creditors and KPMG has made every effort to minimize its disbursements in these cases.

The Requested Compensation Should Be Allowed

22. Section 331 of the Bankruptcy Code provides for compensation of professionals and incorporates the substantive standards of section 330 to govern the Court's award of such compensation. 11 U.S.C. § 331. Section 330 provides that a court may award a professional employed under section 327 of the Bankruptcy Code

"reasonable compensation for actual necessary services rendered . . . and reimbursement for actual, necessary expenses." <u>Id</u>. § 330(a)(1). Section 330 also sets forth the criteria for the award of such compensation and reimbursement:

In determining the amount of reasonable compensation to be awarded, the court should consider the nature, the extent, and the value of such services, taking into account all relevant factors, including—

- (A) the time spent on such services;
- (B) the rates charged for such services;
- (C) whether the services were necessary to the administration of, or beneficial to, at the time at which the service was rendered toward the completion of, a case under this title;
- (D) whether the services were performed within a reasonable amount of time commensurate with the complexity, importance, and nature of the problem, issue, or task addressed; and
- (E) whether the compensation is reasonable based on the customary compensation charged by comparably skilled practitioners in cases other than cases under this title.

Id. § 330(a)(3).

23. The services for which KPMG seeks compensation and the expenditures for which KPMG seeks reimbursement in this Application were necessary for and beneficial to the orderly administration of the Debtors' estates and their rehabilitation and reorganization effort. KPMG worked assiduously to anticipate or respond to the Debtors' needs and assist in the Debtors' chapter 11 processes. These services and expenditures were necessary to and in the best interests of the Debtors' estates and

creditors. Accordingly, the compensation requested herein is reasonable in light of the nature, extent, and value of such services to the Debtors, their estates, and all parties in interest.

24. In sum, the services rendered by KPMG were necessary and beneficial to the Debtors' estates and were consistently performed in a timely manner commensurate with the complexity, importance, and nature of the issues involved, and approval of the compensation for professional services and reimbursement of expenses sought herein is warranted.

Conclusion

WHEREFORE, KPMG respectfully requests that the Court: (i) allow KPMG compensation for professional services rendered during the Compensation Period in the amount of \$4,387,500.68 and reimbursement for actual and necessary expenses KPMG incurred during the Compensation Period in the amount of \$58,868.71; (ii) direct the Debtors to pay KPMG the total amount of outstanding expenses incurred in connection with KPMG's representation of the Debtors during the Compensation Period; (iii) hold that the allowance of such compensation for professional services rendered and reimbursement of actual and necessary expenses incurred be without prejudice to KPMG's right to seek additional compensation for services performed and expenses incurred during the Compensation Period which were not processed at the time of this Application; and (iv) grant KPMG such other and further relief as is just.


