1 **IT IS HEREBY ORDERED** pursuant to Bankruptcy Code §§ 330 and 331 the
2 Application is approved in its entirety; that the total amount of professional fees charged by
3 Andersen to the Debtors during their Chapter 11 cases are reasonable within the meaning of 11
4 U.S.C. § 330(a); that the total amount of reimbursable expenses incurred by Andersen during the
5 Chapter 11 cases were actual and necessary within the meaning of 11 U.S.C. § 330(a); and that
6 final approval is given to all fees and costs previously awarded by interim orders.

8 **IT IS FURTHER ORDERED** that the Debtors are authorized and directed to
9 immediately pay Andersen's request for compensation incurred during this Application Period in
10 the sum of \$85,629.50 and reimbursement of expenses in the sum of \$1,662.20 for a total of
11 \$87,291.70.
