29 This fourth and final application for allowance of compensation (the "Final  
30 Application") is filed by Christensen, Miller, Fink, Jacobs, Glaser, Weil & Shapiro, LLP  
31 ("Christensen Miller"), Special Counsel to Stratosphere Corporation, a Delaware corporation,

8 October 14, 1998 (the "Application Period") are reasonable within the meaning of 11

10 (d) Determining that the total amount of reimbursable expenses incurred by  
11 Christensen Miller during the Application Period are actual and necessary within the  
12 meaning of 11 U.S.C. § 330(a).

14 exhibits hereto, which contain descriptions and analysis of the professional services rendered and  
15 the expenses incurred by Christensen Miller.
