21 **ORDER APPROVING FOURTH AND FINAL APPLICATION OF CHRISTENSEN,
22 MILLER, FINK, JACOBS, GLASER, WEIL & SHAPIRO, LLP FOR
23 LEGAL SERVICES RENDERED AND REIMBURSEMENT OF EXPENSES**

24 This matter having come before the Court on December 10, 1998, for hearing on the
25 "Final Fee Application of Christensen, Miller, Fink, Jacobs, Glaser, Weil & Shapiro, LLP for
26 "Legal Services Rendered and Reimbursement of Expenses" (the "Application") filed by
27 Christensen, Miller, Fink, Jacobs, Glaser, Weil & Shapiro, LLP ("Christensen Miller"); Gary N.
28 Jacobs, Esq. appearing on behalf of Christensen Miller and other appearances as duly noted on
the record; the Court having reviewed the Application of Christensen Miller, the Court having
heard the oral arguments of counsel, and good cause appearing therefor;

1 **IT IS HEREBY ORDERED** pursuant to Bankruptcy Code §§ 330 and 331 that the
2 Application is approved in its entirety; that the total amount of professional fees charged by
3 Christensen Miller to the Debtors during their Chapter 11 cases are reasonable within the
4 meaning of 11 U.S.C. § 330(a); that the total amount of reimbursable expenses incurred by
5 Christensen Miller during the Chapter 11 cases were actual and necessary within the meaning of
6 11 U.S.C. § 330(a); and that final approval is given to all fees and costs previously awarded by
7 interim orders.

8 **IT IS FURTHER ORDERED** that the Debtors are authorized and directed to
9 immediately pay Christensen Miller's request for compensation incurred during this Application
10 Period in the sum of \$10,653.51 and reimbursement of expenses in the sum of \$1,167.31,
11 reduced by the amount of \$9,397.62 for payments already made to Christensen Miller, for a total
12 of \$2,423.00.


