IT IS HEREBY ORDERED that the Court finds a \$800.00 reduction in the fee request to be appropriate, and approves the balance of the Application and Supplement.

IT IS FURTHER ORDERED that for the period July 1, 1998 through closing of the case Shea & Carlyon, Ltd. is awarded the sum of \$12,348.54; consisting of fees in the amount of \$10,917.50 and expenses in the amount of \$1,431.04, to be paid by the Debtors forthwith.


IT IS FURTHER ORDERED that the final approval is given to the fees and costs awarded by the following Orders:


