**SUPPLEMENTAL ORDER APPROVING CERTAIN PORTIONS OF BLANK ROME
LLP'S FINAL FEE APPLICATION AND BLANK ROME LLP'S SUPPLEMENT TO
FINAL FEE APPLICATION**

WHEREAS, by order dated December 20, 2002, this Court approved Blank Rome LLP's¹ Combined Sixth Quarterly and Final Fee Application for Compensation for Services Rendered and Reimbursement of Expenses Incurred as Counsel to the Statutory Committee of Unsecured Creditors of Trans World Airlines, Inc., Et Al. [Dkt. No. 3636], other than those portions of fees sought by Blank Rome aggregating \$744,000 which remained subject to objections filed by American Airlines, Inc., and other than additional fees totaling \$25,757.00 and costs totaling \$1,567.05 sought by Blank Rome subsequent to its filing of its Final Fee Application in a Supplement to its Final Fee Application [Dkt. No. 3905] filed November 7, 2002. No objections to the Supplement were filed or served. Accordingly, Blank Rome's total fee request is \$769,757.00 plus \$1,567.05 for expenses.

WHEREAS, Blank Rome and American Airlines have reached an agreement to resolve the outstanding fee application objections filed by American Airlines, by which Blank Rome will reduce its fee request by \$50,000 and American Airlines will withdraw its objections.

IT IS HEREBY ORDERED:

1. Blank Rome's Final Fee Application, subject to the reduction of \$50,000.00, is approved in whole and on a final basis. The fee application objections filed by American Airlines shall be deemed withdrawn.

2. Blank Rome shall be allowed \$719,757.00 as its final compensation for services rendered to the Statutory Committee of Unsecured Creditors and \$1,567.05 as reimbursement of expenses.

3. The TWA Inc. Post Confirmation Estate and its agents are hereby authorized and directed to pay Blank Rome the amounts set forth above in paragraph 2 within seven (7) days of the date of this Order.


