**SECOND APPLICATION OF THE OFFICIAL COMMITTEE OF
RETIRES FOR REIMBURSEMENT OF EXPENSES INCURRED BY
MEMBERS OF THE OFFICIAL COMMITTEE OF RETIREES**

TO THE HONORABLE PETER J. WALSH,
UNITED STATES BANKRUPTCY JUDGE:

The Official Committee of Retirees (the “Retirees’ Committee”) of Trans World Airlines, Inc., *et al.* (the “Debtors”), by its undersigned counsel Traub, Bonacquist & Fox LLP (“TB&F”) submits this second application for reimbursement of expenses incurred by members of the Retirees’ Committee, pursuant to §503(b)(3)(F) of the Bankruptcy Code, and respectfully represents as follows:

INTRODUCTION

1. On January 10, 2001 (the “Petition Date”), the Debtors filed with this Court voluntary petitions for relief under chapter 11 of title 11, United States Code, 11 U.S.C. §

101, *et seq.* (the “Bankruptcy Code”). The Debtors continue to operate their businesses and manage their properties pursuant to §§ 1107 and 1108 of the Bankruptcy Code.

2. Pursuant to the Order Under Sections 105(a) and 331 of the Bankruptcy Code Establishing Procedures for Interim Compensation and Reimbursement of Expenses for Professionals and Committee Members, dated January 10, 2001 (the “Administrative Order”), retained professionals and committee members are authorized to file monthly fee applications no earlier than the 25th day of each month following the month for which compensation is sought. The Administrative Order requires each professional or committee member filing a monthly fee application to serve notice of the fee application on the Debtors, Debtors’ counsels, counsel to the Debtors’ post-petition lender, counsel to the Official Committee of Unsecured Creditors, counsel to any other statutory committee appointed by the Office of the United States Trustee, and the United States Trustee.

3. No trustee or examiner has been appointed herein.

4. This is the second application for reimbursement of expenses filed by the members of the Retirees’ Committee and covers expenses incurred by Captain John P. Gratz, Mr. John Edmond, and Mr. Fernando Arenas for the period covering July 10, 2001 (the “Expense Period.”).

5. Section 503(b)(3)(F) of the Bankruptcy Code generally provides that the actual, necessary expenses, incurred by members of a committee appointed under §1102 of the Bankruptcy Code, in the performance of their duties, shall be an allowed administrative expense.

7. To discharge its statutory duties in these proceedings, it has been necessary for the Committee members to incur travel and other related expenses in the course of attending and participating in meetings with the Debtors. As set forth in §1103(c) of the Bankruptcy Code, the Retirees' Committee and its members are charged with, among others, the duties of: (a) consulting with the Debtors concerning the administration of these cases; (b) investigating the acts, conduct, assets, liabilities and financial condition of the Debtors, and other matters relevant to the cases.

8. In connection with, and in furtherance of the performance of their duties as members of the Retirees' Committee members of the Committee has incurred expenses and seek reimbursement thereof, as follows:

Copies of the invoices submitted to counsel by the Retirees' Committee members, setting forth and itemizing, in detail each of the expenses for which reimbursement is requested, are attached as Exhibit "A" to this Application. The members of the Retirees' Committee respectfully reserves its rights to submit future reimbursement requests as well as reimbursement requests not otherwise requested herein, at a later date.

10. No payments have been made or promised to the members of the Retirees' Committee as reimbursement for the expenses incurred in connection with these cases. None of the amounts of reimbursement requested herein represent or include fees or other compensation in the nature of wages, salaries or otherwise for personal services rendered by the members of the Retirees' Committee. The reimbursement sought herein is limited solely to the actual, necessary expenses incurred by the members of the Retirees' Committee in the performance of the duties of the Retirees' Committee. Accordingly, it respectfully request that the reimbursement of expenses sought herein be allowed in full.

WHEREFORE, the Retirees' Committee respectfully requests that the Court allow and authorize the reimbursement of the expenses set forth above in the aggregate amount of \$2,202.63 with such expenses to be paid by the Debtors immediately upon approval thereof, and such other relief as the Court may deem necessary and proper.
