THIS MATTER is before the Court on the "First And Final Application Of Pricewaterhouse Coopers LLP ("PWC") As Claims Agent For Debtors and Debtors In Possession For Allowance Of Compensation And Reimbursement Of Expenses" dated March 19, 1999 (the "Claims Agent Application") and the "First And Final Application Of Pricewaterhouse Coopers LLP As Accountants to Provide Special Litigation Assistance For Debtors and Debtors-In-Possession For Allowance Of Compensation And Reimbursement Of Expenses" dated March 19, 1999 (the "Accountant Application," and together with the Claims Agent Application, the "PWC Applications"). RainTree Healthcare Corporation (f/k/a Unison HealthCare Corporation) and its affiliated reorganized codebtors captioned above (collectively, "RainTree") reserved the right to object to the PWC Applications by virtue of two Stipulated Orders of the Court extending the time within which RainTree could file and serve any objection to the PWC Applications.

THE COURT FINDS AND CONCLUDES as follows:

- A. This matter represents a core proceeding in which this Court may enter final and dispositive orders in accordance with 28 U.S.C. §§ 1334 and 157(b).
- B. The Claims Agent Application seeks allowance of compensation of \$255,669.00 and reimbursement of \$10,559.44 in expenses that PWC incurred throughout its engagement as claims agent in these Chapter 11 cases.

- C. The Accountant Application seeks allowance of compensation of \$266,183.50 and reimbursement of \$1,480.59 in expenses that PWC incurred throughout its engagement as special litigation accountant to RainTree in these Chapter 11 cases.
- D. RainTree disputes that the full amount of compensation sought to be approved in the PWC Applications is reasonable under Bankruptcy Code § 330.
- E. PWC and RainTree wish to compromise and settle their disputes regarding the amount of compensation to be allowed to PWC under the PWC Applications and, accordingly, have executed this Stipulated Order below to indicate their respective assent to the relief granted below in full settlement and satisfaction of the PWC Applications.
 - F. Sufficient cause exists to grant the relief below.

NOW, THEREFORE, IT IS ORDERED that:

- 1. The PWC Applications are GRANTED to the extent consistent with the terms and conditions contained in this Stipulated Order.
- 2. Final compensation to PWC in the amount of \$465,000 (the "Approved Fees") is approved in full satisfaction of the Claims Agent Application and the Accountant Application and all services that PWC rendered in these Chapter 11 cases. Additionally, \$12,040.03 in total expenses (the "Approved Expenses") are approved and are to be reimbursed as provided in this Stipulated Order.
- 3. RainTree is authorized and directed to remit to PWC payment in the full amount of the Approved Expenses as soon as practicable after entry of this Stipulated Order, and under no circumstances after May 17, 1999. RainTree is authorized and directed to remit to PWC: (a) payment of at least \$230,000 of the Approved Fees no later than June 15, 1999; (b) payment of at least \$115,000 of the remaining Approved Fees no later than July 15, 1999; and, (c) payment of any remainder of the Approved Fees no later than August 16, 1999.

4. As no objection to the PWC Applications were filed with the Court, the status hearing currently scheduled for April 27, 1999 at 1:00 p.m. is vacated with respect to the PWC Applications.
