ORDER APPROVING SIXTH QUARTERLY AND SEVENTEENTH MONTHLY APPLICATIONS OF MESIROW FINANCIAL CONSULTING, LLC FOR COMPENSATION AND REIMBURSEMENT OF EXPENSES AS RESTRUCTURING ADVISORS TO THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS FOR THE PERIOD OCTOBER 1, 2005 THROUGH JANUARY 31, 2006

Upon consideration of the Sixth Quarterly Application and Seventeenth Monthly Application of Mesirow Financial Consulting, LLC ("MFC") for Compensation and Reimbursement of Expenses as Restructuring Advisors to the Official Committee of Unsecured Creditors for the quarterly period October 1, 2005 through December 31, 2005 (the "Sixth Quarterly Application") and for the monthly period January 1, 2006 through January 31, 2006 (the "Seventeenth Monthly Application"), respectively, under 11 U.S.C. §§ 330 and 331, in accordance with the Administrative Order Pursuant to 11 U.S.C. §§ 105(a) and 331 Establishing Procedures for Interim Compensation and Reimbursement of Expenses of Professionals entered by this Court on December 11, 2002 (collectively, the "Applications"); the Court having reviewed the Applications; the Court having found that it has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; it appearing that adequate notice of the Applications has been given and that no other or further notice is necessary; and after due deliberation thereon; and good and sufficient cause appearing therefor,

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED THAT:

1. The Applications are hereby approved and granted.

2. MFC is granted an interim administrative allowance of \$1,645,650 (comprised of

\$1,220,702 for the Sixth Quarterly Application and \$424,948 for the Seventeenth

Monthly Application) for necessary professional services rendered and \$38,385

(comprised of \$28,527 for the Sixth Quarterly Application and \$9,858 for the

Seventeenth Monthly Application) for expenses incurred for the period of October 1,

2005 through January 31, 2006 (the "Application Periods").

3. The Debtors are hereby authorized and directed to pay the outstanding amount of the

sums described in paragraph 2 hereof in the amount of \$164,565, representing fees

held back for the Application Periods less MFC's voluntary reduction for fees and

expenses incurred.

4. The Court shall retain jurisdiction to hear and determine all matters arising from the

implementation of this Order.
