ORDER GRANTING FINAL APPLICATION OF PAUL, HASTINGS, JANOFSKY & WALKER LLP FOR ALLOWANCE OF ADMINISTRATIVE CLAIM FOR COMPENSATION AND REIMBURSEMENT OF EXPENSES FOR THE PERIOD FROM DECEMBER 9, 2002 THROUGH SEPTEMBER 30, 2004

Paul, Hastings, Janofsky & Walker LLP ("Paul Hastings"), as special labor counsel and special litigation counsel to the above-captioned debtors and debtors in possession (collectively, the "Debtors"), having filed a Final Application for Allowance of Compensation and Reimbursement of Expenses for the Period from December 9, 2002 through September 30, 2004 (the "Application") (DOCKET NO. 15532); the Court having reviewed the Application; it appearing that the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; it appearing that this proceeding is a core proceeding within the meaning of 28 U.S.C. § 157(b)(2); it appearing that venue is proper in this District pursuant to 28 U.S.C. §§ 1408 and 1409; the Court having reviewed the Reports prepared by the Fee Review Committee in these Chapter 11 cases; such Reports having been filed and served; adequate and proper notice of the Application having been given; it appearing that no other or further notice need be given; no objections to the Application having been afforded the

opportunity to be heard on the Application; and after due deliberation and sufficient cause appearing therefore, IT IS HEREBY ORDERED THAT:

- 1. The Application is GRANTED, on a final basis;
- 2. For the period from December 9, 2002 through September 30, 2004, an administrative allowance be made to Paul Hastings in the sum of \$1,111,579.50 for necessary professional services rendered and \$45,421.62 for expenses incurred;
- 3. Paul Hastings is hereby authorized and directed to return to the Debtors funds held in trust in the amount of \$7,198.85;
- 4. Paul Hastings is hereby authorized and directed to return to the Debtors funds in the amount of \$1,261.15, representing computerized legal research charges that the Debtors paid and that Paul Hastings subsequently agreed to waive;
- This Court shall retain jurisdiction to hear and determine all matters arising from the implementation of this Order;
- 6. Notwithstanding the possible applicability of Bankruptcy Rules 6006(d), 7062, 9014, or otherwise, the terms and conditions of this Order shall be immediately effective and enforceable upon its entry; and

7. All time periods set forth in this Order shall be calculated in accordance with Bankruptcy Rule 9006(a).
