FINAL FEE APPLICATION OF LATHAM & WATKINS LLP FOR ALLOWANCE AND PAYMENT OF COMPENSATION AND REIMBURSEMENT OF EXPENSES AS COUNSEL FOR THE DEBTOR

Pursuant to sections 330, 331 and 503(b)(1)(A) of the Bankruptcy Code, 11 U.S.C. §§ 101-1330 (the "Bankruptcy Code"), Rule 2016 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules") and Amended Guidelines for Fees and Disbursements for Professionals in Southern District of New York Bankruptcy Cases adopted by the Court on April 19, 1995 (the "Local Guidelines") and the United States Trustee Guidelines for Reviewing Applications for Compensation and Reimbursement of Expenses Filed Under 11 U.S.C. § 330, adopted on January 30, 1996 (the "UST Guidelines"), Latham & Watkins LLP ("Latham"), counsel to the above-captioned debtor and debtor-in-possession in the above-captioned chapter 11 case (collectively, the "Debtor"), respectfully submits this second and final application (the "Application") for: (i) allowance of \$202,304.00 for compensation and \$21,198.64 as reimbursement for expenses for the period from November 1, 2002 through March 18, 2003 (the "Interim Compensation Period") and (ii) final allowance of \$398,448.50 for compensation and \$31,190.44 as reimbursement for expenses for the period from March 29, 2002 through March 18, 2003 (the "Final Compensation Period") (which includes final approval of the previous fee application filed by Latham for the period of March 29, 2002 through October 31, 2002 as well as final approval for the Interim Compensation Period).

In support of this Application, Latham respectfully represents as follows:

Background

- 1. On March 29, 2002 (the "Petition Date"), the Debtor filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code. The Debtor is continuing in possession of its properties and managing its business as authorized under sections 1107 and 1108 of the Bankruptcy Code.
- 2. On May 13, 2002, this Court entered an order approving the retention of Latham as counsel for the Debtor *nunc pro tunc* to the Petition Date. By Order dated May 13, 2002 (the "Administrative Order"), the Court established the procedure for interim compensation and reimbursement of expenses for all professionals in this case. In particular, the Court authorized that, absent objection, upon the expiration of twenty days after the service of a monthly interim fee application, the Debtor was authorized to pay each professional an amount equal to 80 percent of the fees and 100 percent of the expenses requested in such monthly interim fee application. Pursuant to the procedures set forth in the Administrative Order, Latham received \$161,843.20 in fees and \$21,198.64 in expenses for the Interim Compensation Period pursuant to monthly statements.
- 3. On February 19, 2003, Latham filed its first interim fee application seeking interim approval and allowance of compensation covering the period of March 29, 2002 through October 31, 2002. On March 19, 2003, this court entered an order approving interim compensation for professional services rendered to the Debtor in the amount of \$196,144.50 and reimbursement of expenses in the amount of \$9,991.80, and authorized payment of the fees held back pursuant to the Administrative Order in the amount of \$39,228.90. In this Application, Latham seeks approval of its fees and expenses incurred by the Debtor during the Final

Compensation Period as well as payment of the holdback from the Interim Compensation Period in the amount of \$40,460.80.

- 4. Further, on March 18, 2003, the Debtor's Plan of Reorganization was confirmed by this Court. The Effective Date under the Plan was April 18, 2003.
- 5. The supervisory responsibility for Latham's efforts on behalf of the Debtor has been borne by Martin N. Flics, a partner in Latham's New York office. Mr. Flics is a 1976 graduate of Hampshire College and a 1979 graduate of Fordham University Law School. Mr. Flics concentrates his practice in bankruptcy and restructuring.

Summary of Services Performed During the Interim Compensation Period

- 6. Latham seeks approval of \$223,502.64 incurred during the Interim Compensation Period on account of fees and expenses. Latham also requests a final total award for the Final Compensation Period of \$429,638.94 of which \$398,448.50 is for fees and \$31,190.44 is for expenses.
- As is reflected in the Final Fee and Expense Application Cover Sheet (the "Cover Sheet"), during the Interim Compensation Period, Latham has rendered 546.30 hours of legal services in the representation of the Debtor from November 1, 2002 through March 18, 2003.

 Based on the nature of the services rendered, the time required, the value of the services to the Debtor and its estate, and the cost of comparable services other than in a case under the Bankruptcy Code, the compensation for these services should not be less than \$202,304.00. This total represents 546.30 hours of Latham attorney and other professional time, at an average hourly rate of \$370.32. The hourly rate for each attorney and other professional who performed services for the Debtor is set forth in the Cover Sheet.

- 8. In accordance with the Local Guidelines, Exhibit "A," attached hereto and incorporated herein by reference, contains a detailed chronological narrative of the time spent, the dates and descriptions of the services rendered, and the identity of the attorneys and other professionals who provided services on behalf of the Debtor from March 29, 2002 through March 18, 2003, divided among certain uniform categories adopted at the outset of this case. Section III of the Cover Sheet, attached hereto and incorporated herein by this reference, contains a summary of the services provided by project category.
- 9. Latham respectfully supplements the chronological narrative of the time spent, the dates and descriptions of services rendered by the professionals who worked on this engagement and the related disbursements incurred on behalf of the Debtor with the following narrative summary of the services rendered by Latham, organized by category:
- a. General Case Administration Latham rendered a total of 326.10 hours and \$102,967.00 in services in the category "General Case Administration," which includes all of the time spent participating in strategic meetings, advising the Debtor regarding the status of the case, and addressing issues that arose in connection with the administration of this case. This also includes representing the Debtor in all matters relating to the sale of its assets to Castle Harlan Australian Mezzanine Partners No. 1A Trust (as described in the Disclosure Statement) and responding to numerous creditor inquiries regarding the case status.
- **b.** Motions and General Litigation Latham rendered a total of 53.80 hours and \$16,510.00 in services in the category "Motions and General Litigation." This project category contains all of Latham's services rendered in connection with filing of a motion to extend time to file schedules, motions to extend the exclusive period, a motion establishing a bar date and motions to approve the Disclosure Statement and Plan of Reorganization.

- \$3,337.00 in services in the category "Representing Debtor in Court." This project category includes Latham's services in connection with representing the Debtor during hearings which sought approval of the Disclosure Statement and confirmation of the Plan, as well as numerous case status conferences and various other court appearances.
- **d.** <u>DIP Financing.</u> Latham rendered a total of 107.10 hours and \$46,929.50 in services in the category "DIP Financing." This project category includes Latham's services in connection with documenting the post-petition financing facility, including negotiation of the relevant documentation and attending the DIP hearing.
- e. Plan and Plan Issues. Latham rendered a total of 571.80 hours and \$228,705.00 in services in the category "Plan and Plan Issues." This project category includes Latham's services in drafting and negotiating the terms of the Debtor's Plan and Disclosure Statement, dated December 20, 2002. In addition, Latham prepared, drafted and distributed the voting ballots for solicitation of votes on the Plan. The solicitation packages were mailed on February 3, 2003. During the solicitation period, Latham responded to inquires regarding the Plan. Also during the Interim Compensation Period, Latham attorneys performed services in connection with the preparation of the confirmation brief and proposed order and affidavits, preparation for the confirmation hearing, and reviewing of the ballots.

Latham's Staffing and Internal Procedures.

7. Latham has made a conscious effort in this case to provide the Debtor with high quality legal services at the lowest possible cost. Whenever possible, rather than "recreating the wheel," Latham has called upon the considerable expertise of its senior partners to obtain quick answers to difficult questions without the need for expensive and time consuming legal research.

Where research has been required, Latham has utilized the low billing rates of junior lawyers, resulting in considerable savings for the Debtor. Latham respectfully submits that it has been extremely efficient in avoiding duplication of effort and keeping fees and costs at the lowest level possible.

8. Latham believes that the attached time detail reflects the actual, fair and reasonable value of the legal expertise provided to the Debtor, and for the benefit of the Debtor's estate, which required skilled and experienced legal counsel with knowledge not only of bankruptcy law, but also securities, tax and other substantive areas of law.

Disbursements

- 9. Latham also expended a total of \$21,198.64 for reasonable and necessary expenses in connection with its representation of the Debtor from November 1, 2002 through March 18, 2003, and a total of \$31,190.44 during the Final Compensation Period. In accordance with the Guidelines, Section IV of the Cover Sheet, attached hereto and incorporated herein by reference, also contains a summary of the expenses incurred by type.
- 10. Latham does not build a profit component into its disbursements and charges the Debtor's estates only Latham's actual out-of-pocket expenses. Photocopy charges are billed at \$0.17 per page and outgoing faxes are billed at \$1.25 per page.
- 11. In the normal expense reconciliation process, Latham often receives invoices for expenses several weeks or months after such charges have accrued. To the extent any such reasonable expenses are billed to Latham on account of services provided to the Debtor during the Final Compensation Period, Latham proposes to provide the U.S. Trustee and the Debtor with reasonable documentation of such charges. If no objection is made to such expenses within 10 days after giving notice, the Debtor will be authorized to pay these expenses without the need to seek further Court approval.

Certification

12. As required by the Guidelines, Exhibit "B" attached hereto and incorporated herein by reference, contains Latham's certification that the Debtor has reviewed and approved Latham's Application, that the facts set forth in this Application are true and correct and that the Application complies with the Guidelines.

Latham is a Disinterested Person and Holds No Adverse Interest

- 13. All professional services for which allowance of compensation is requested were performed by Latham on behalf of the Debtor and not on behalf of any other entity or person. Latham owns neither a claim against, nor an interest in the Debtor, and no beneficial interest in the Debtor, directly or indirectly, has been acquired or transferred by Latham or for Latham's benefit since the commencement of this case. Latham represents no interest adverse to the Debtor with respect to matters upon which it is engaged and Latham is a "disinterested person" under section 101(14) of the Bankruptcy Code.
- 14. No agreement or understanding exists between Latham and any other person or entity for sharing of compensation received or to be received for services rendered in connection with these proceedings, except that fees will be shared with other partners of Latham as permitted by Bankruptcy Rule 2016 and section 504 of the Bankruptcy Code.

WHEREFORE, Latham respectfully requests that this Court allow (i) interim compensation in the sum of \$ 202,304.00 for actual, reasonable and necessary professional services rendered on behalf of the Debtor during the Interim Compensation Period; (ii) final reimbursement in the amount of \$21,198.64 for actual, reasonable and necessary expenses incurred during the same period; (iii) final allowance of \$398,448.50 in fees and \$31,190.44 in expenses for the Final Compensation Period; and (iv) payment of 40,460.80 for the amounts held back for the Interim Compensation Period (including application of amounts held as retainer by Latham).
